

WAIVER OF OBJECTION

In the Matter of the Petition of David M. Haala, as Trustee of the David M. Haala Revocable Living Trust under agreement dated January 1, 2017 for Annexation of Certain Unincorporated Territory to the City of Sleepy Eye.

WHEREAS, the Home Township Board for Home Township, Brown County, Minnesota, has received a copy of the Petition to Annex signed by David M. Haala, as Trustee of the David M. Haala Revocable Living Trust under agreement dated January 1, 2017, the property owner in the hereinafter described property, and

WHEREAS, the petition seeks to annex the following property to the City of Sleepy Eye, which is now located in Home Township, Brown County, Minnesota, to-wit:

Part of the Balance of Lot N in the Southwest Quarter of Section 32, Township 110 North, Range 32 West, Brown County, Minnesota, described as follows: Beginning at the Southwest corner of Lot 2, Block 1, HAALA'S THIRD ADDITION, according to the recorded plat thereof; thence South 89 degrees 50 minutes 23 seconds East, bearings based on the Brown County Coordinate System NAD 83(96), on the south line of said Lot 2, a distance of 286.83 feet to the Northwest corner of said Lot 1A, Block 1, HAALA'S NINTH ADDITION, according to the recorded plat thereof; thence South 15 degrees 36 minutes 50 seconds East on the west line of said Lot 1A, a distance of 77.94 feet to the Southwest corner of said Lot 1A; thence North 89 degrees 50 minutes 23 seconds West, a distance of 307.92 feet to a point on the southerly extension of the west line of said Lot 2; thence North 00 degrees 05 minutes 25 seconds East on said southerly extension, a distance of 75.00 feet to the point of beginning. Contains 0.51 acres of land (hereinafter "Property").

The Property is to be platted, following annexation, as Haala's Eleventh Addition, City of Sleepy Eye, Brown County, Minnesota; and

WHEREAS, the Home Township Board has reviewed the petition of the proposed annexation and agrees to the annexation of the property above described to the City of Sleepy Eye on the condition that the final annexation Ordinance contain a clause reimbursing Home Township for lost real estate taxes in the amount of \$50.00 per year for the next two years.

NOW, THEREFORE, the Home Township Board agrees to waive any objections to the annexation of the above-described property to the City of Sleepy Eye and further waives the 90 days which they have to file an objection of said annexation as allowed per Minnesota Statute Section 414.033 Subd. 5.
