

ORDINANCE NO. 24, THIRD SERIES

AN ORDINANCE OF THE CITY OF GLENWOOD, MINNESOTA, ANNEXING LAND LOCATED IN GLENWOOD TOWNSHIP, POPE COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES § 414.033, SUBDIVISION 3, PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, a Notice of Intent for the Annexation of Certain real property to the City of Glenwood pursuant to Minn. Stat. § 414.033, Subd. 3, was served by mail on February 26, 2020, and the City of Glenwood has not received any objections to the annexation; and

WHEREAS, said property is unincorporated and abuts the City of Glenwood and is bordered more than 60% by the City of Glenwood; is less than 40 acres; is not presently served by public sewer facilities; and

WHEREAS, said property is not located within a flood plain or shore land area; and

WHEREAS, said property is currently zoned commercial and annexation is requested to facilitate the extension of city services for the commercial development of the property and the land is urban or suburban in character and no part of the land included is within the limits of an incorporated city; and

WHEREAS, the provisions of Minn. Stat. § 414.033, Subd. 13, are not applicable in that there will be no change in the electric utility service provider resulting from the annexation of the territory to the municipality;

NOW, THEREFORE, THE CITY COMMISSION OF THE CITY OF GLENWOOD ORDAINS:

1. The City Commission hereby determines that the property as hereinafter described abuts the city limits and the perimeter of the area to be annexed by the City of Glenwood is 60% or more bordered by the City of Glenwood and is or is about to become urban or suburban in nature and that commercial use is being proposed for said property, the construction of which requires or will require city services, including public sewer facilities.

2. None of the property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minn. Stat. § 414.0325.

3. The corporate limits of the City of Glenwood, Minnesota, are hereby extended to include the following described property, said land abutting the City of Glenwood and being 40 acres or less in area. The land to be annexed is legally described as follows:

The above-described property consists of a total of 26.87 acres, more or less.

4. The population of the area legally described in Exhibit A and hereby annexed is zero.

5. The City of Glenwood, pursuant to Minn. Stat. § 414.036, with respect to property taxes payable on the area legally described in Exhibit A, hereby annexed, shall make a cash payment to Glenwood Township in accordance with the following schedule:

a. In the first year following the year in which the City of Glenwood could first levy on the annexed area, an amount equal to \$42.77; and

b. In the second and final year, an amount equal to \$42.77. There are no outstanding assessments against the land, and there exists no debt incurred by the Township prior to the effective date of this ordinance attributable to the property to be annexed but for which no special assessments are outstanding.

6. The City Administrator of the City of Glenwood is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, The Pope County Auditor, and the Glenwood Township Clerk.

7. This Ordinance shall be in full force and effect upon the date this Ordinance is approved by the Office of Administrative Hearings.
