

orderly annexation to the Village of Sauk Rapids, and


WHEREAS, The legal description of the property is:

DESCRIPTION

All that part of Oakridge Addition, Oakridge 3rd Addition, and all of Sections 15 and 16, Township 36 North, Range 31 West, Benton County, Minnesota lying within the following description: Commencing at the intersection of the North line of Section 14 of said Township 36 North, Range 31 West with the Northwestern right-of-way line of new State Trunk Highway # 152; thence Southwesterly along said right-of-way line to its intersection with the Northerly right-of-way line of North Highview Drive as platted in Oakridge 3rd Addition extended Easterly for the point of beginning of the tract to be described; thence Westerly along said right-of-way line of North Highview Drive and said line extended to its intersection with the centerline of West Highview Drive; thence Northwesterly along said centerline to its intersection with the South boundary line of ~~Blocks~~ 5 and 6 of said Oakridge 3rd Addition extended Easterly; thence Westerly along said boundary line and said line extended to the Southeasterly right-of-way line of Ridge Road as platted in Oakridge 2nd Addition; thence Southwesterly along said right-of-way line and said right-of-way line extended to its intersection with the Northeasterly right-of-way line of Benton Drive, formerly known as T.H. #10; thence Southwesterly at right angles to said Northeasterly right-of-way line of Benton Drive to its intersection with the Southwesterly right-of-way line of the Burlington Northern Railroad; thence Southeasterly along said right-of-way line to its intersection with the South line of the North half of Government Lot 3 in said Section 15; thence Easterly along said South line to its intersection with the Northeasterly right-of-way line of Benton Drive; thence Northwesterly along said right-of-way line to the South line of Lot 4, Block 4, Oakridge 3rd Addition; thence Easterly along said South line of Lot 4 to the Southwesterly right-of-way line of West Highview Drive; thence Southeasterly along said right-of-way line to the Southerly right-of-way line of East Highview Drive extended; thence Easterly along said right-of-way line and said line extended and along the South line of Lot 23, Block 3, Oakridge 3rd Addition to its intersection with the West line of the Southeast quarter of said Section 15; thence Southerly along said West line to its intersection with the Northwesterly right-of-way line of new State Trunk Highway #152; thence Northeasterly along said right-of-way line to the point of beginning.

All that part of Oakridge Addition, Oakridge 3rd Addition, and all of Sections 15 and 16, Township 36 North, Range 31 West, Benton County, Minnesota lying within the following description: Commencing at the intersection of the North line of Section 14 of said Township 36 North, Range 31 West with the Northwestern right-of-way line of new State Trunk Highway # 152; thence Southwesterly along said right-of-way line to its intersection with the Northerly right-of-way line of North Highview Drive as platted in Oakridge 3rd Addition extended Easterly for the point of beginning of the tract to be described; thence Westerly along said right-of-way line of North Highview Drive and said line extended to its intersection with the centerline of West Highview Drive; thence Northwesterly along said centerline to its intersection with the South boundary line of **Blocks** 5 and 6 of said Oakridge 3rd Addition extended Easterly; thence Westerly along said boundary line and said line extended to the Southeasterly right-of-way line of Ridge Road as platted in Oakridge 2nd Addition; thence Southwesterly along said right-of-way line and said right-of-way line extended to its intersection with the Northeasterly right-of-way line of Benton Drive, formerly known as T.H. #10; thence Southwesterly at right angles to said Northeasterly right-of-way line of Benton Drive to its intersection with the Southwesterly right-of-way line of the Burlington Northern Railroad; thence Southeasterly along said right-of-way line to its intersection with the South line of the North half of Government Lot 3 in said Section 15; thence Easterly along said South line to its intersection with the Northeasterly right-of-way line of Benton Drive; thence Northwesterly along said right-of-way line to the South line of Lot 4, Block 4, Oakridge 3rd Addition; thence Easterly along said South line of Lot 4 to the Southwesterly right-of-way line of West Highview Drive; thence Southeasterly along said right-of-way line to the Southerly right-of-way line of East Highview Drive extended; thence Easterly along said right-of-way line and said line extended and along the South line of Lot 23, Block 3, Oakridge 3rd Addition to its intersection with the West line of the Southeast quarter of said Section 15; thence Southerly along said West line to its intersection with the Northwesterly right-of-way line of new State Trunk Highway #152; thence Northeasterly along said right-of-way line to the point of beginning.
