

RESOLUTION NO. 90-73

AMENDMENT TO THE JOINT RESOLUTION
FOR ORDERLY ANNEXATION BETWEEN
LAKETOWN TOWNSHIP AND THE CITY OF
VICTORIA, MINNESOTA, PURSUANT TO
MINNESOTA STATUTES 414.0325, SUBD.1.

WHEREAS, Edward J. Moores and Janet Padelford are sole owners in fee of the tract of land described below, and made a part hereof and filed with the City of Victoria a petition for annexation of said lands into the corporate limits of the City of Victoria.

NOW, THEREFORE, BE IT RESOLVED, That Laketown Township and the City of Victoria hereby jointly agree that the joint resolution between Laketown Township and the City of Victoria designating an area for Orderly Annexation, dated December 2, 1976, be amended to include the following:

Both Laketown Township and the City of Victoria agree that no alteration of the stated boundaries of this agreement is appropriate.

FURTHERMORE, BE IT FURTHER RESOLVED, That both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following described property, in accordance with the terms of the joint resolution:

That part of Government Lot 1, Section 15, Township 116, Range 24, and that part of Government Lot 6, Section 10, Township 116, Range 24, Carver County, Minnesota, described as follows: Beginning at the Reference Corner on the shore of Lake Auburn, said Reference Corner being on the east line of said Government lot 1, distance 16.5 feet south from the Northeast corner of said Section 15; thence South, assumed bearing, along the east line of said Government Lot 1 a distance of 600.0 feet; thence on a bearing of West a distance of 330.0 feet; thence North parallel with the east line of said Government Lot 1 a distance of 649.70 feet; thence North 39 49' East a distance of 139.5 feet more or less to the shore of Lake Auburn; thence woutheasterly along the shore of Lake Auburn to the point of beginning, except that part of said Government Lot 1 described as follows: Beginning at the Reference Corner on the east line of said Government Lot 1; thence South, assumed bearing, along the east line of said Government Lot 1 a distance of 175.0 feet; thence North 52 22'19" West a distance of 110.0 feet; thence North 37 37'41" East a distance of 140 feet more or less to the shore of Lake Auburn; thence easterly along said shore to the point of beginning.

Together with an easement of or road purposes over and across all that part of the East 33 feet of said Government Lot 1, lying south of the south line of the above described tract, and lying northerly of the northerly right of way line of State Trunk Highway NO.5.
