AND THE TOWN OF LAKETOWN PURSUANT TO )
MINNESOTA STATUTES 414 )

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Victoria and the Town of Laketown and duly accepted by the Minnesota Municipal Board; and

WHEREAS, an amendment to the joint resolution was received from the City of Victoria and the Town of Laketown indicating their desire that certain property be annexed to the City of Victoria pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on February 4, 1991, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Victoria, Minnesota, the same as if it had originally been made a part thereof:

That part of Government Lot 1, Section 15, Township 116, Range 24, and that part of Government Lot 6, Section 10, Township 116, Range 24, Carver County, Minnesota,

described as follows: Beginning at the Reference Corner on the shore of Lake Auburn, said Referenc Corner being on the east line of said Government lot 1, distance  $16.\bar{5}$ feet south from the Northeast corner of said Section 15; thense South, assumed bearing, along the east line of said Government Lot 1 a distance of 600.0 feet; thence on a bearing of West a distance of 330.0 feet; thence North parallel with the east line of said Government Lot 1 a distance of 649.70 feet; thence North 39 49' East a distance of 139.5 feet more or less to the shore of Lake Auburn; thence woutheasterly along the shore of Lake Auburn to the point orf beginning, except that part of said Government Lot 1 described as follows: Beginning at the Reference Corner on the east line of said Government Lot 1; thence South, assumed bearing, along the east line of said Government Lot 1 a distance of 175.0 feet; thence North 52 22'19" West a distance of 110.0 feet; thence North 37 37'41" East a distance of 140 feet more or less to the shore of Lake Auburn; thence easterly along said shore to the point of beginning.

Together with an easement of or road purposes over and across all that part of the East 33 feet of said Govbernment Lot 1, lying south of the south line of the above described tract, and lying norhterly of the norterly right of way line of State Trunk Highway NO.5.

IT IS FURTHER ORDERED: That the effective date of this order is February 4, 1991.
