ORDINANCE NO. 191

AN ORDINANCE ANNEXING TERRITORY AND EXTENDING CITY LIMITS

THE CITY COUNCIL OF THE CITY OF DAWSON, MINNESOTA DOES HEREBY ORDAIN THE FOLLOWING:

SECTION I: That it is hereby found and determined that that certain real estate situated in Lac qui Parle County, Minnesota, described as follows, to-wit:

Tracts of land located in the Northwest Quarter of the Northwest Quarter ($NW_{4}^{1}NW_{4}^{1}$) of Section Twenty-two (22), Township One Hundred Seventeen (117) North, of Range Forty-three (43) West, beginning at the Northwest corner of said section, thence east on the section line twelve point seventy-six chains (12.76 ch), thence south five point five chains (5.5 ch), thence west twelve point seventy-six chains (12.76 ch) to the west line of said section, thence north on said west section line to the place of beginning; also a tract of land beginning at a point twelve point seventy-six chains (12.76 ch) east of the Northwest corner of said section, thence continuing east on the north line of said section to the Northeast corner of the Northwest Quarter of the Northwest Quarter ($NW_{\pm}^{1}NW_{\pm}^{1}$) of said section, thence south one hundred feet (100'), thence west to the east line of the first described tract, thence north on said East line to the place of beginning; also the West three hundred thirty feet (330')of the Southeast Quarter of the Southwest Quarter (SELSWL) of Section Fifteen (15), Township One Hundred Seventeen (117) North, of Range Forty-three (43) West.

abuts on and is immediately adjacent to the northeasterly limits of the City of Dawson, Minnesota, and is presently agricultural land but is now or is about to become urban or suburban in character, and that it is to the best interests of the City of Dawson and of said above described territory that it be annexed to the City of Dawson for all government purposes.

SECTION II. That it is also hereby found and determined that the petition of the owners of said property, praying for such annexation, was duly filed with the City of Dawson, the Town of Riverside, the County of Lac qui Parle, and with the Minnesota Municipal Commission, pursuant to the provisions of Section 414.033, Subdivision 5, of Minnesota Statutes Annotated, and that no objections thereto have been presented or filed.

SECTION III: That all of said real estate described in Section I hereof is hereby annexed to the City of Dawson. Minnesota, for all governmental purposes and that the city limits of the City of Dawson are hereby extended and enlarged to include the same, and that all thereof is hereby zoned as commercial property and is assigned to and made a part of the First Ward of Dawson.

SECTION IV: That this ordinance shall be in effect from and after final passage and publication and that true and correct copies thereof be forwarded to and filed with Minnesota Municipal Commission, the County Auditor of Lac qui Clerk, Town of Riverside, Parle County, Minnesota,/and the Secretary of State of the State of Minnesota.


