RESOLUTION NO. 8070

AUTHORIZING THE FOLLOWING OF THE NECESSARY PAPERS OF THE INTENT TO ANNEX.

WHEREAS, the City of Austin is concerned a certain territory as described below which is not presently included in the corporate limits of the City of Austin, and

WHEREAS, the City Council has met informally with the Austin Township Board to discuss the territory below described, and

WHEREAS, this area would be aided by annexation by the provision of municipal services. The area as to be proposed is at least 60% surrounded and is in an area that will be urban in character.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Common Council of the City of Austin, Minnesota, that the Austin Township Board and the Lansing Township Board, Minnesota Municipal Commission, and Mower County Board of Commissioners be notified of the intent of the City Council to annex the following described parcel of land under the 60% surrounded law which is allowed under Minnesota Statutes 414.033, Subdivision 3:

Beginning at a point 843.8 ft. north of the SW corner of the E 1/2 of the NE 1/4 of the NW 1/4 of Sec. 4, T102N, R18W, Mower County, Minnesota, thence north on the west line of said east half of the NE 1/4 of said NW 1/4 to the north line of the NW 1/4 of said Sec. 4 this point also being the south line of Sec. 33, T103N, R18W, thence continuing northerly on the west line of the east half of the SE 1/4 of the SW 1/4 of Section 33, T103N, R18W for a distance of 528 ft. thence easterly on a line parallel to the south line of said SW 1/4 a distance of 80 ft. thence southerly on a line parallel to the east line of said SW 1/4 a distance of 264 ft, thence easterly on a line parallel to the south line of said SW 1/4 a distance of 330 ft. thence northerly on a line parallel to the east line of said SW 1/4 a distance of 264 ft. thence easterly on a line parallel to the south line of said SW 1/4 to the east line of said southwest 1/4 of Sec. 33 thence southerly on the east line of said SW 1/4 to the SE corner of the SW 1/4 of Sec. 33 this point also being the NE corner of the NW 1/4 of said Sec. 4 thence easterly on the north line of said Sec. 4 to a point 33 ft. north of the NE corner of Outlot 4 of the plat of outlots in the east half of the NE 1/4 of the NW 1/4 and the NW 1/4 of the NW 1/4 of the NE 1/4 of said Sec. 4 thence southerly to the NE corner of said Outlot 4, thence southerly on the east line of said Outlot to the SE corner of said Outlot 4 this point also being on the north property line of Sixth Avenue N.W. thence westerly on the north property line of Sixth Avenue N.W. to a point 100 ft. west of the SE corner of Outlot 5 in plat of said outlots thence northerly on a line parallel to the west line of said Outlot 5 a distance of 150 ft. thence westerly on a line parallel to the south line of said Outlot 5 a distance of 65 ft. to the west line of said Outlot 5 this point also being on the east line of Outlot 6 of said plat of outlots thence westerly on a line parallel to the south line of Outlot 6 a distance of 100 ft. thence northerly on a line parallel to the west line of Outlot 6 to the north line of the S. 1/2 of Outlot 6 thence westerly 65 ft. on the north line of S. 1/2 of Outlot 6 to the west line of Outlot 6 thence southerly on the west line of Outlot 6 to the SW corner of Outlot 6 this point also being the SE corner of Outlot 8 in plat of said outlots thence westerly 210 ft. on the south line of Outlot 8 thence northerly on a line parallel to the west line of Outlot 8 a distance of 150 ft. thence westerly on a line parallel to the south line of Outlot 8 a distance of 54 ft. to the west line of Outlot 8 thence southerly on said west line of Outlot 8 a distance of 15 ft. to the NE corner of Sub Outlot 5 in the plat of Heald Subdivision thence westerly on the north line of Sub Outlots 1, 2, 3, 4 and 5 of Heald Subdivision to the point of beginning.




