Hutchinson, described as follows:


That part of the Northeast Quarter of the Southeast

Addition and in McDonald's Sixth Addition, a distance  
of 825.00 feet; thence southerly, parallel with  
said east line, a distance of 120.00 feet; thence  
easterly, parallel with said south line of McDonald  
Drive and its westerly extension, a distance of 825.00  
feet to said east line; thence northerly, along said  
east line, a distance of 120.00 feet to the point of  
beginning.

WHEREAS, the above-described land is unplatted, does  
not exceed 200 acres in area, and 100% of the owners of said  
land have petitioned the City Council of the City of Hutchinson  
for annexation;

NOW, THEREFORE, notice is hereby given to the Minnesota  
Municipal Board, the Town Board of Lynn Township, and the County  
Board of McLeod County, that the city of Hutchinson intends to  
annex the above-described land pursuant to MSA 414.033 Subdivision  
5, and will so annex the land if no written objections are  
received from the Town Board or the County Board within ninety  
(90) days from the service of this Notice upon the Town Board  
and County Board.

WHEREAS, authority to effect such annexation is vested in the City,


NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUTCHINSON:

That part of the Northeast Quarter of the Southeast Quarter of Section 2, Township 116 North, Range 30 West of the 5th Principal Meridian, described as follows:



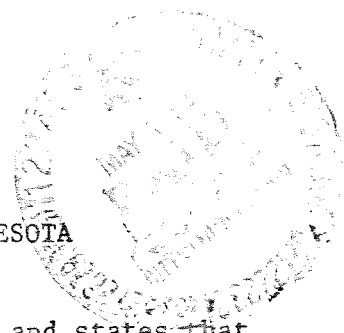

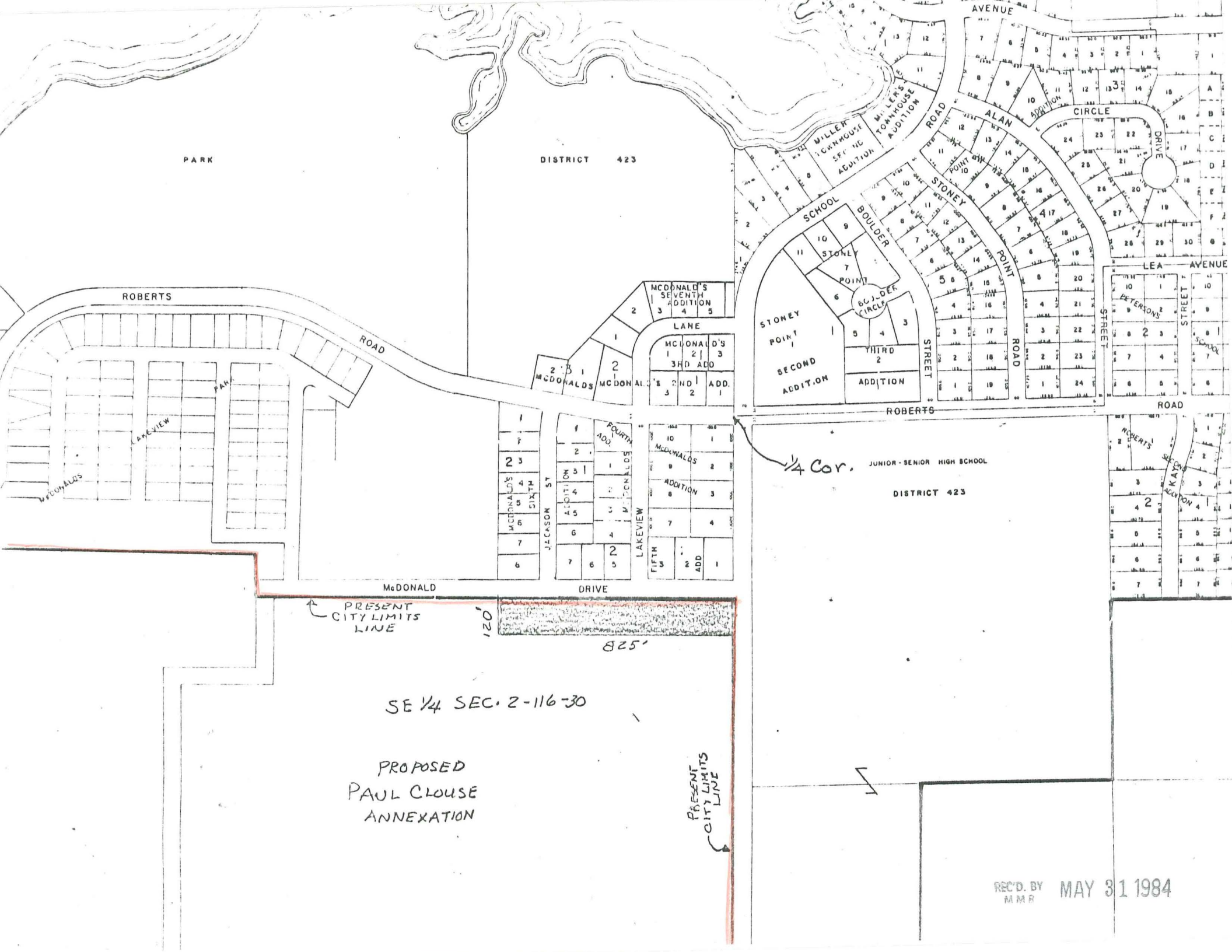
