Please be advised that the City of Hutchinson is dropping the request for a portion of the annexation shown in Resolution No. 7757; specifically, the tracts of land that are to be dropped from this portion on the annexation request are as follows:

1. The North 33 feet of the NW 1/4 of Section 12, Township 116 North, Range 30 West, from School Road to County State Aid Highway No. 7, Lynn Township
2. The South 33 feet of the SW 1/4 of Section 1, Township 116 North, Range 30 West, except the West 600 feet and except the East 900 feet, Lynn Township

This legal description is matched with Exhibit A.

The City of Hutchinson does want to proceed with the annexation shown in Exhibit B along Highway 15 South between the intersections of South Grade Road and South City limits.

Please advise us if this amendment is required to be done by Resolution.





AMENDMENT TO RESOLUTION NO. 7757 ENTITLED
"REQUEST FOR ANNEXATION"

WHEREAS, on the 22nd day of May, 1984, the City Council of the city of Hutchinson adopted Resolution No. 7757 entitled "Request for Annexation", whereby the city of Hutchinson petitioned for annexation of four tracts of property legally described as:


1. The East 33 feet of the North $\frac{3}{4}$ of the NE $\frac{1}{4}$ of Section 12, Township 116 North, Range 30 West. Lynn Township.
2. The West 33 feet of the NW $\frac{1}{4}$ of Section 7, Township 116 North, Range 29 North. Hassan Valley Township.
3. The North 33 feet of the NW $\frac{1}{4}$ of Section 12, Township 116 North, Range 30 West, from School Road to County State Aid Highway No. 7. Lynn Township.
4. The South 33 feet of the SW $\frac{1}{4}$ of Section 1, Township 116 North, Range 30 West, except the West 600 feet and except the East 900 feet. Lynn Township.

AND, WHEREAS, it has been determined that tracts three and four thereof are not 60% or more bordered by territory already included within the city limits,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUTCHINSON, THAT resolution No. 7757 adopted by the Hutchinson City Council on the 22nd day of May, 1984 is amended by deleting the request for annexation of Tract Three legally described as: The North 33 feet of the NW $\frac{1}{4}$ of Section 12, Township 116 North, Range 30 West, from School Road to County State Aid Highway No. 7. Lynn Township. and Tract Four legally described as: The South 33 feet of the SW $\frac{1}{4}$ of Section 1, Township 116 North, Range 30 West, except the West 600 feet and except the East 900 feet. Lynn Township.

WHEREAS, the City Council of the City of Hutchinson hereby requests the described property to be annexed to the City of Hutchinson, and


WHEREAS, authority to effect such annexation is vested in the City,

THAT, annexation of the following tracts be put into effect:


1. The East 33 feet of the North 3/4 of the NE 1/4 of Section 12, Township 116 North, Range 30 West. Lynn Township.


