IN THE MATTER OF THE PETITION OF CERTAIN PERSONS FOR ANNEXATION TO THE CITY OF WINDOM, COTTONWOOD COUNTY, MINNESOTA

The undersigned Petitioners hereby represent and show to the City Council of the City of Windom, Cottonwood County, Minnesota:

1. That your Petitioners hereby petition the City Council of the City of Windom, Minnesota, to annex to said city the following described premises abutting said city:

All that part of the Southwest Quarter of the Northeast Quarter and of the Northwest Quarter of the Southeast Quarter of Section 22, Township 105, Range 36, described as follows:

Beginning at the point of intersection of the most Westerly point of Lot 1 in Block 2 in Kountry Acres Subdivision No. 2, an addition to the City of Windom, with the Southeasterly line of Kalash Road; thence running Southeasterly on and along the Southwesterly lines of Lots 1 and 2 in Block 2 in Kountry Acres Subdivision No. 2 a distance of 437 feet, more or less to the most Easterly point of said Lot 2; thence Southwesterly at right angles to the Southwesterly line of said Lot 2 a distance of 202 feet to the center line of County State Aid Highway No. 13; thence Northwesterly on and along the center line of County State Aid Highway No. 13 a distance of 437 feet, more or less to the point of intersection with the Southeasterly line of Kalash Road extended Southwesterly; thence Northeasterly on and along the Southeasterly line of Kalash Road extended a distance of 200 feet more or less to the point of beginning.

Excepting therefrom the following described tract:

All that part of the Southwest Quarter of the Northeast Quarter of said Section 22 described as follows:

Commencing at a point 400 feet East and 161 feet North of the Southwest corner of the Southwest Quarter of said Section 22, said point being on the center line of State Aid Road No. 13, thence in a Southeasterly direction along said center line for a distance of 60 feet, this being the point of beginning; thence Northeasterly at right angles to said center line for a distance of 202 feet; thence Southeasterly at right angles for a distance of 75 feet; thence Southwesterly at right angles for a distance of 202 feet; to a point in said center line which is 75 feet Southeasterly of the point of beginning; thence Northwesterly along said center line to the point of beginning.

- 2. That attached hereto, marked Exhibit "A" and made a part hereof, is a map showing the area above described and proposed for annexation.
- 3. That your Petitioners are all of the freeholders in the property above described and proposed for annexation.
- 4. That there are approximately 1.87 acres of land in the area proposed for annexation.
- 5. That there are 10 residents in the area proposed for annexation.
- 6. That there are 3 single family detached dwellings with accessory structures in the area proposed for annexation.

- 7. That the area proposed for annexation is not presently served by public water and sewer, but that the City of Windom has indicated that it will serve said property with water and sewer in the event that it is annexed. That the area is subject to Cottonwood County Zoning regulations. That there is no police protection in said area. That Great Bend Township presently furnishes fire protection for said area under a contract with the City of Windom. That County State Aid Highway No. 13, also known as River Road, is the public highway servicing said area.
- 8. That said area is urban in character and is so conditioned as to be properly subject to municipal government.
- 9. That said area abuts Kountry Acres Subdivision No. 2, an addition to the City of Windom, on its Northeast side and that it abuts an unplatted area of the City of Windom, on its Southeast side.
