AN ORDINANCE ANNEXING CERTAIN ABUTTING LAND INTO THE CITY.

Pursuant to the provisions of Sec. 414.033 of the Minnesota Statutes and a petition filed in accordance therewith and all of the requirements of said statute having been fulfilled;

The City Council of Big Falls ordains:

1. That the following described real property is hereby annexed to the City of Big Falls and the corporate limits of the City are extended to include such property. The description of said property is as follows:

All of Government Lot Eight (8), Section Thirty-six (36), Township One Hundred Fifty-five (155), Range Twenty-five (25), lying South of the Big Fork River, Koochiching County, Minnesota.

2. This Ordinance shall become final upon its approval by the Minnesota Municipal Board.



of Big Falls pursuant to Sec. 414.033, Subdiv. 5 of the Minnesota Statutes.


