PETITION FOR ANNEXATION  
CITY OF EITZEN  
HOUSTON COUNTY, MINNESOTA

TO THE HONORABLE EITZEN CITY COUNCIL:

The undersigned for their ANNEXATION petition state and allege that they are all of the owners of record of certain lands included in the premises described and set forth below;

That said lands are unplatted and constitute an area of less than 200 acres;

That said hereinafter described tract is purposed to be annexed to the City of Eitzen abuts on the present City of Eitzen municipal boundary and is now of urban or suburban character.

The lands, the subject matter of this petition are described as follows, to-wit:

PARCEL A

That part of the southeast quarter of the southwest quarter of Section 32, Township 101 North of Range 5 West of the Fifth Principal Meridian described as commencing at a point which is the intersection of the south City limits of the City of Eitzen and the centerline of Iowa Avenue in said City. Thence southwesterly along the centerline of Iowa Avenue 363.3 feet to the place of beginning of the parcel to be described. Thence east 200.9 feet thence south 243 feet thence west 238.3 feet to the centerline of Iowa Avenue thence north along said centerline 247.45 feet to the place of beginning except public right of way.

PARCEL B

~~Also that part of the southwest quarter of the southwest quarter and of the southeast~~ quarter of the southwest quarter of Section 32, Township 101 North of Range 5 West of the Fifth Principal Meridian lying and being within the right-of-way of Minnesota State Trunk Highway #76 and Iowa Avenue adjacent and easterly thereof which part is bounded on the north by the present corporate limits of the City of Eitzen and on the south by the Minnesota-Iowa State line, subject to the State of Minnesota Trunk Highway right-of-way easement.

WHEREFORE, your honorable council is petitioned to initiate and process to conclusion this annexation petition, annexing the aforescribed lands by ordinance according to the statute in such cases made and provided, and in connection therewith to serve copies hereof upon the Municipal Board of the State of Minnesota, the Town Board of the Town of Winnebago and the Houston County Board of Commissioners.
