1. That the legal description set forth on Page 1 of Resolution No. 1986-1-3 be amended as follows:

All that part of said Township that lies northerly and westerly of the thread of the Sauk River LESS AND EXCEPT that portion thereof that lies within the present corporate limits of the City of St. Cloud.

Together with that part of said Township that lies southerly of the present corporate limits of the City of St. Cloud, easterly of the centerline of Minnesota State Trunk Highway No. 15, and westerly of the easterly right-of-way line of Stearns County Road No. 75 (formerly known as Minnesota State Trunk Highway No. 152), LESS AND EXCEPT the Southwest Quarter (SW 1/4) of Section 27, the Southeast and Southwest Quarters (SE 1/4) and (SW 1/4) of Section 28, all of Section 33, the Northwest, Southwest and Southeast Quarter (NW 1/4), (SW 1/4) and (SE 1/4) of Section 34, and that part of Section 32 and the Southeast Quarter (SE 1/4) of Section 29 that lie easterly of the centerline of Minnesota State Trunk Highway No. 15.

And together with that part of said Township described as follows, to-wit: That part of the Northeast Quarter of the Southwest Quarter (NE 1/4 of SE SW 1/4) of Section 21 that lies northerly and westerly of the centerline of Minnesota State Trunk Highway No. 15.
