## PETITION FOR ANNEXATION

TO THE HONORABLE MEMBERS OF THE STILLWATER CITY COUNCIL:

1. The undersigned Petitioner,

Gilbert J. Benson, a single person 1002 Pine Tree Trail Stillwater, Minnesota 55082

is the owner of land in Stillwater Township legally-described on Exhibit "A" attached hereto and made a part hereof by this reference.

- 2. The Petitioner's land is adjoining and contains, collectively, 1.58 acres, more or less.
- 3. The Petitioner brings this Petition for the reason that the annexation of his said lands to the City of Stillwater is in the best interest of those lands because:
  - (a) Fifty percent (50%) of the said land is bordered by the City of Stillwater and fifty percent (50%) of the said land is surrounded by the Town of Stillwater.
  - (b) The abutting lands in the City of Stillwater are developed for residential purposes and the City is providing to both those abutting lands and the Petitioner's said lands (such municipal services include sanitary sewer and municipal water service) to both those abutting lands and Petitioner's said land.
  - (c) Petitioner's said lands are subject to deferred assessment for said services.
  - (d) The availability of such municipal services will permit the highest and best use of Petitioner's lands consistent with regional and local land use planning - namely, urban density residential use with all necessary and desirable municipal services.
  - 4. The Petitioner's property proposed for annexation is, now,

urban in character.

5. The Town of Stillwater can continue to carry on the function of government without undue hardships as a result of the proposed annexation.

WHEREFORE, Petitioner respectfully requests that the City
Council of the City of Stillwater adopt an ordinance, under the
provisions of Section 414.033, Subdivision 5 of the Minnesota
Statutes finding and determining that the Petitioner's said lands
are now urban in character and annexing the said lands to the City
of Stillwater.

## LEGAL DESCRIPTION OF GILBERT J. BENSON PROPERTY
