

ORDINANCE NO. 301

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MILACA, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City of Milaca, Minnesota, at the Northerly boundaries thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City;

THE CITY COUNCIL OF MILACA, MINNESOTA, ORDAINS:

Section 1. Territory Annexed. The corporate limits of the City of Milaca, Minnesota, are hereby extended to include the unplatted property described as follows now owned by the City:

FIRST ANNEXED TRACT:

The West 653.00 feet of the South 350.00 feet of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Twenty-four (24), Township Thirty-eight North (38N), Range Twenty-seven West (27W), subject to Public Highway Easements of record (and all lines parallel to appropriate section lines.)

SECOND ANNEXED TRACT:

The West One-half of the Southeast Quarter (W $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of Section Twenty-four (24), Township Thirty-eight (38), Range Twenty-seven (27), subject to public roads and highways of record, less and excepting therefrom the following described tracts, to-wit:

(1) First excepted tract: All that part thereof shown as Parcel 8 on the Plat designated as Minnesota Department of Transportation right-of-way Plat 48-12, containing 14.58 acres, more or less;

(2) Second excepted tract: All that part thereof lying and being easterly of Minnesota Trunk Highway #169 right-of-way and easterly of said Parcel 8 of Minn. DOT Plat numbered 48-12, containing 14.38 acres, more or less;

(3) Third excepted tract: The West 312.9 feet of the South 1117.0 feet of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Twenty-four (24), Township Thirty-eight (38), Range Twenty-seven (27), subject to public roads and highways of record (all lines parallel to appropriate section lines);

Section 2. Filing. The City Manager is directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Township of Milaca, the County Auditor of Mille Lacs County and the Minnesota Secretary of State.

Section 3. Effective Date of Annexation. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.

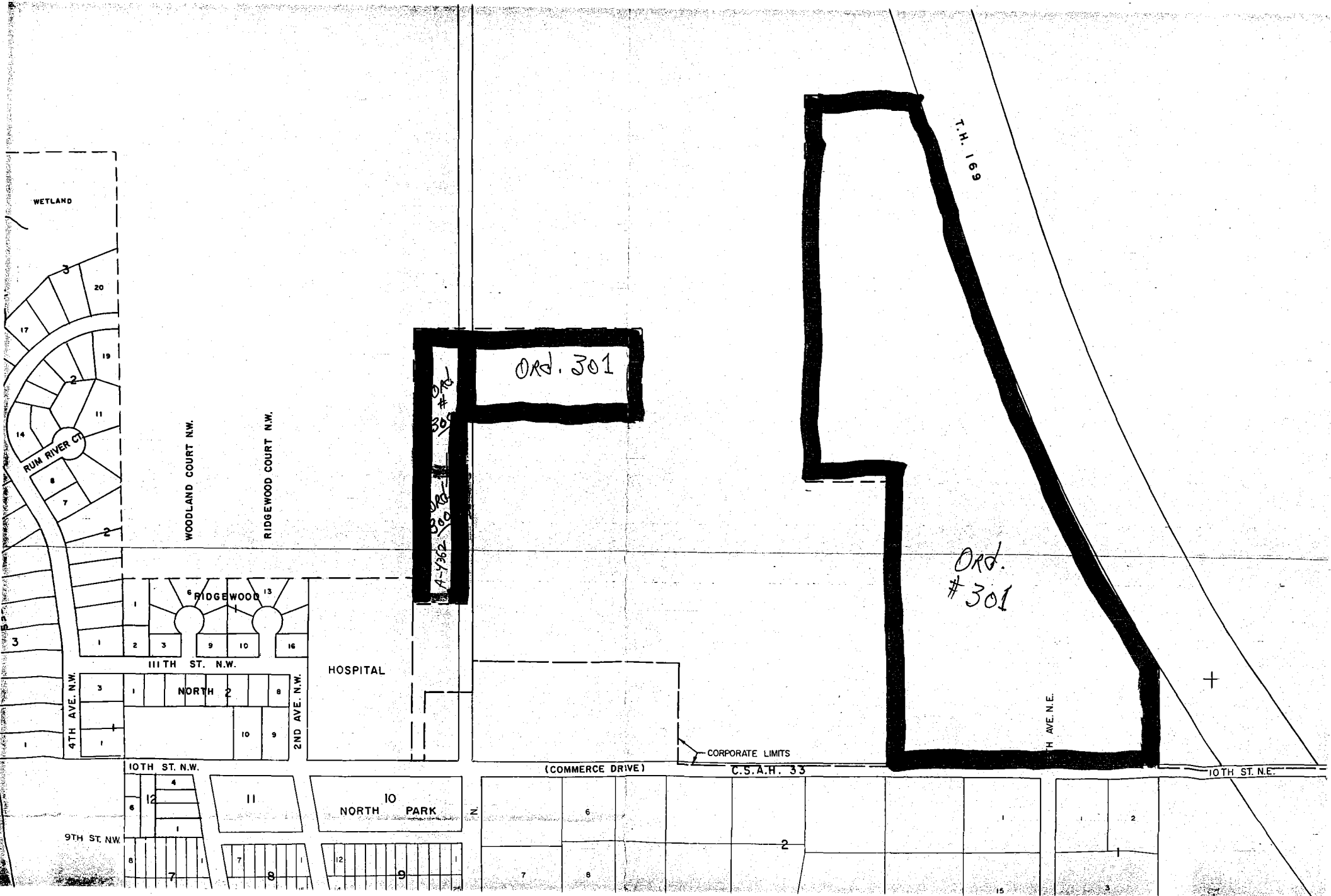

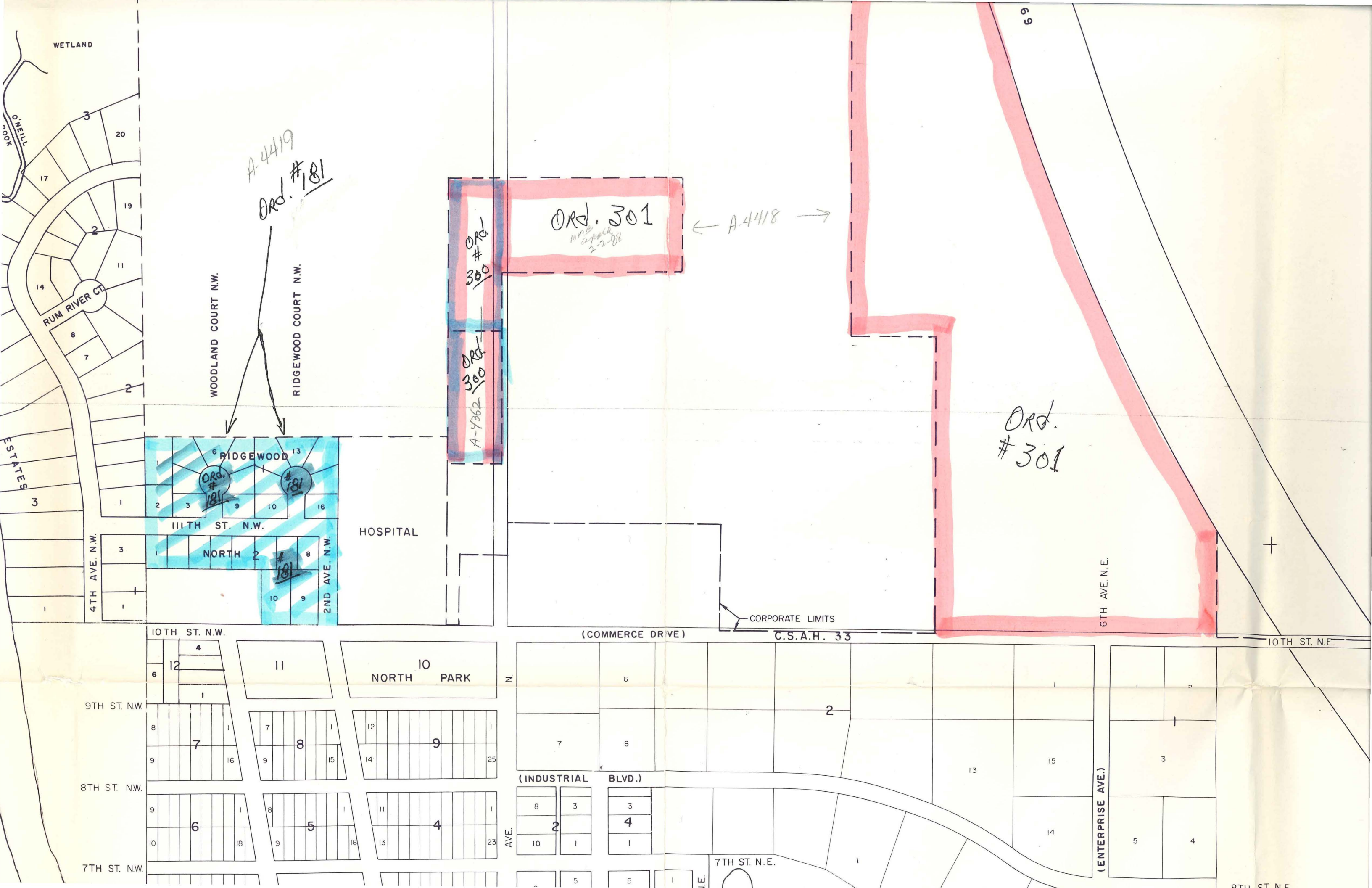
