ORDINANCE NO. 0-88-11

CITY OF DELANO WRIGHT COUNTY, MINNESOTA

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DELANO TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated May 24, 1988, requesting annexation of the territory hereinafter described was duly presented to the Council and accepted on June 7, 1988; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, the petition was duly served on Franklin Township and the Township has filed a Waiver of Objection with the Municipal Board; and

WHEREAS, no objections to the annexation have been received from the Town Board of Franklin Township or the governing body of any municipality whose boundaries abutt upon the boundaries of the land to be annexed within ninety (90) days of the service of the petition upon them; and

WHEREAS, the land described in the petition abutts upon the City limits;

THE COUNCIL OF THE CITY OF DELANO, MINNESOTA, ORDAINS:

Section 1. The City Council hereby determines (1) that the territory described herein abutts upon the City limits and is or is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of the City.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the platted land described in Exhibit "A" attached hereto and made a part hereof and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

The City Clerk is hereto directed to Section 3. Filing. file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, and the Town Clerk, and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Municipal Board.
