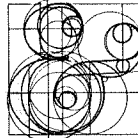

A part of the West Three-fourths of the North Quarter of Section 16, Township 106 North, Range 14 West, Olmsted County, Minnesota, described as follows:

Beginning at the northeast corner of the Northwest Quarter of said Section 16; thence North 89 degrees 43 minutes 14 seconds West, assumed bearing, along the north line of said Northwest Quarter, 923.00 feet; thence South 00 degrees 03 minutes 14 seconds East, 262.40 feet; thence South 87 degrees 43 minutes 14 seconds East, 43.88 feet; thence South 06 degrees 55 minutes 23 seconds East, 235.46 feet to the northerly line of MAYOWOOD HILLS according to the plat thereof on file and of record in the office of the Olmsted County, Minnesota, Recorder (and the next nine courses are along said northerly line); thence South 84 degrees 46 minutes 30 seconds East, 1116.19 feet; thence southeasterly 252.73 feet along a tangential curve concave southwesterly, central angle of 32 degrees 40 minutes 00 seconds and radius of 443.28 feet; thence South 52 degrees 06 minutes 30 seconds East, 9.60 feet; thence southeasterly 215.10 feet along a tangential curve concave northeasterly, central angle of 32 degrees 40 minutes 00 seconds and radius of 377.28 feet; thence South 84 degrees 46 minutes 30 seconds East, 22.70 feet; thence easterly 182.83 feet along a tangential curve concave southerly, central angle of 17 degrees 16 minutes 00 seconds and radius of 606.69 feet; thence South 67 degrees 30 minutes 30 seconds East, 21.60 feet; thence easterly 181.19 feet along a tangential curve concave northerly, central angle of 19 degrees 12 minutes 00 seconds and radius of 540.69 feet; thence South 86 degrees 42 minutes 30 seconds East, 153.80 feet to the northeast corner of said MAYOWOOD HILLS; thence North 04 degrees 37 minutes 14 seconds East, 870.12 feet to the northeast corner of the Northwest Quarter of the Northeast Quarter of said Section 16; thence North 89 degrees 43 minutes 42 seconds West along the north line of said Northeast Quarter a distance of 1316.70 feet to the point of beginning.

A part of the Northeast Quarter of Section 16, Township 106 North, Range 14 West described by metes and bounds as follows:

Commencing at the Northeast corner of said Section 16, thence West along the North line of said section to its intersection with the center line of County State Aid Highway No. 8, formerly State Aid Road "P," a distance of 55.5 feet for a place of beginning; thence Southwesterly along the center line of said road at a deflection angle of 83 degrees 12 minutes to the left from the previous described course for a distance of 7.4 feet to Engineer's Station 80 + 48.96, which is the beginning of a 4 degrees transition curve with 150 foot spirals and a deflection angle of 38 degrees 24 minutes to the right, thence Southwesterly along the center line of said road to Engineer's Station 69 + 38.96, which is the end of said transition curve, a distance of 1110.0 feet; thence continue along the center line of said road a distance of 860.77 feet to the beginning of a curve to the left of radius of 5729.58 feet and delta angle 10 degrees 48 minutes, thence along said curve for a distance of 468.1 feet, thence North at a deflection angle of 145 degrees 15 minutes with the semi-tangent of said curve for a distance of 328.5 feet, thence North at a deflection angle of 4 degrees 20 minutes to the left for a distance of 125.0 feet, thence North at a deflection angle of 8 degrees 20 minutes to the left for a distance of 200.0 feet to the Southeast corner of Mayowood Hills, thence continue North on the previous described course for a distance of 48.2 feet, thence Northerly at a deflection angle of 1 degrees 07 minutes right from the previous described course for a distance of 100.0 feet, thence Northerly at a deflection angle of 4 degrees 17 minutes right from the previous described course for a distance of 100.0 feet, thence Northerly at a deflection angle of 1 degrees 20 minutes right from the previous described course for a distance of 1072.0 feet to the Northwest corner of the Northeast Quarter Northeast Quarter, said Section 16, thence East along the North line of said Quarter section for a distance of 1261.2 feet to the place of beginning.

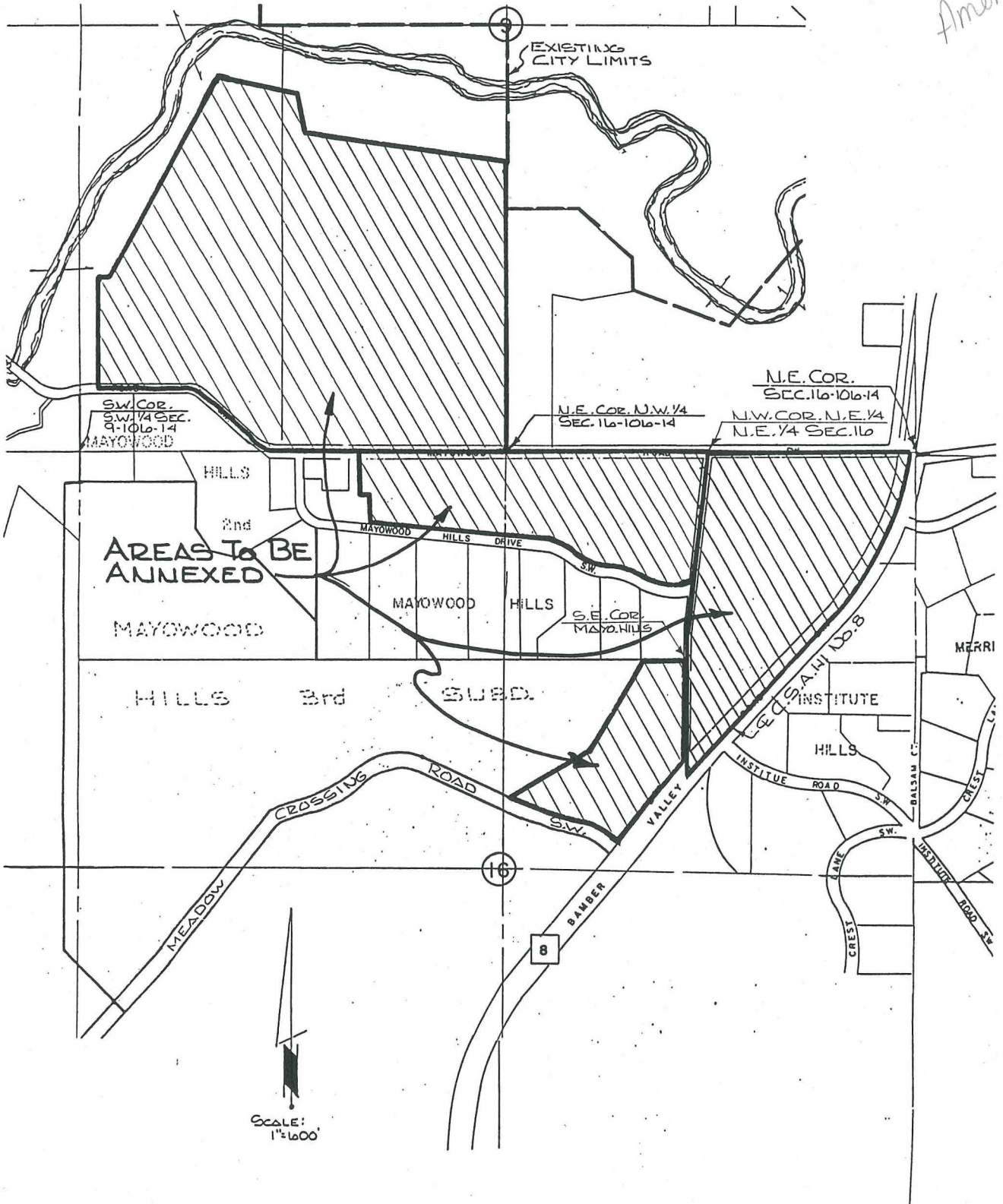


# SKETCH OF AREAS TO BE ANNEXED
