PETITION FOR ANNEXATION  
(COHRS)

TO: THE HONORABLE CITY COUNCIL OF THE CITY OF MAYER, MINNESOTA:

The undersigned Petitioners hereby respectfully request and state to the City Council of the City of Mayer as follows:

1. That they are all of the property owners of the land hereinafter described except any part thereof that is included within a public street, road, highway or right of way, and that they make this Petition pursuant to Minnesota Statutes Section 414.033, Subd. 5.
2. That they desire and request that certain land be annexed to the City of Mayer, Carver County, Minnesota, and included within the corporate limits of the City of Mayer, including all streets, roads or highways passing through or adjacent to said lands as shown on the map of said lands attached hereto and made a part hereof. Said land being legally described as follows:

That part of the Southwest Quarter of Section 31, Township 117, Range 25, Carver County, Minnesota, described as follows:

Beginning at a point in the South line of said Southwest Quarter distant 398.4 feet East of the Northwest corner of Section 6, Township 116, Range 25; thence North perpendicular to said South line 200.0 feet; thence West parallel with said South line 217.8 feet; thence South at right angles 200.0 feet to said South line; thence East along said South line 217.8 feet to the point of beginning.

3. That said land abuts the present corporate limits of the City of Mayer; that said land is not platted and does not exceed 200 acres in area; that said land is not now included within any municipality, nor does said land border any other municipality.

4. That said land contains approximately 1 acre of land including streets and highways.
5. That your Petitioners believe that said land is conditioned as properly to be subject to municipal government and that said annexation should be in the best interests of the City of Mayer and of the land proposed to be annexed.
6. That the undersigned Petitioners make this Petition to the Honorable City Council of the City of Mayer, Carver County, Minnesota, in accordance with and pursuant to Minnesota Statutes Section 414.033, Subd. 5, and pray that the City Council will accept this Petition and take all action necessary for annexation of the above described land under the authority granted by said statute.
