## ORDINANCE NO. 8-2-89

AN ORDINANCE ANNEXING TO THE CITY OF EDGERTON, MINNESOTA, APPROXIMATELY 6 ACRES OF LAND IN THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER  $(NW_4^1SE_4^1)$ OF SECTION 21, TOWNSHIP 105, RANGE 44, EDGERTON, MINNESOTA

THE CITY COUNCIL OF THE CITY OF EDGERTON DO ORDAIN:

Section 1. A petition has been filed with the City Council of the City of Edgerton, signed by the owner of land described herein, requesting the City Council to annex said land to the City of Edgerton. The land described in said petition for annexation is located in Osborne Township, Pipestone County, Minnesota, and is described together with adjacent public road right-of-way as follows:

> The East Three Hundred Ninety-six (E.396) feet of the South Six Hundred Sixty (S.660) feet of the Northwest Quarter of the Southeast Quarter  $(NW_4^1SE_4^1)$  of Section Twenty-one (21), Township One Hundred Five (105) North, Range Forty-four (44) West of the 5th P.M., containing six (6) acres, more or less, and subject to Highway and REA easements, if any.

Said petition has also been filed with the Town Board of Osborne Township, with the County Board of the County of Pipestone, and with the Minnesota Municipal Board, and the Town Board of Osborne Township has notified the City that it has no objections to the annexation of the above-described land.

Section 2. The quantity of land included in said petition is approximately six (6) acres in size.

Section 3. The City Council of the City of Edgerton does hereby determine that the land described in Section 1 abuts upon the present territorial limits of the City of Edgerton, is so conditioned æ to be properly subjected to municipal government, and the annexation of said land will be in the best interest of the City of Edgerton and the land described.

Section 4. Therefore, the land described in Section 1 above is hereby annexed, added to and made a part of the City of Edgerton, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. Present and future owners of the lands annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the City Council to assess against benefited property all or a portion of the cost of any storm sewer, water tower, and trunk line sanitary sewer construction, heretofore or hereafter undertaken to serve the area annexed.

Section 6. This ordianance shall take effect an be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Board, the Edgerton Town Clerk, the County Auditor, and the Secretary of State, and approval by the Minnesota Municipal Board.
