LEGAL DESCRIPTION

Parcel A -- Stuart Ystebo Property: A parcel of land located in the Northwest Quarter of Section 10, Township 139 North, Range 48 West of the Fifth Principal Meridian, and more fully described as follows:

Commencing at the Northwest Corner of said Section 10, thence South 0 degrees 17 minutes East a distance of 90.00 feet; thence North 89 degrees 17 minutes East a distance of 69.8 feet to the point of beginning; thence along the south right-of-way line of U.S. Highway No. 10 to the Northwest Corner of Lot 7 in Block 7, Gullings Subdivision; thence south along the west side of Lots 7 and 18 in Block 7, Gullings Subdivision to the Southwest Corner of Lot 18; thence North 89 degrees 17 minutes East a distance of 150.00 feet to the Southeast Corner of Block 7, Gullings Subdivision; thence South 0 degrees 40 minutes East parallel with the north-south quarter line of said Section 10 to the north right-of-way line of Northern Pacific Railroad; thence westerly along the north right-of-way line of Northern Pacific Railroad to a point 69.8 feet east of the west section line of said Section 10; thence North 0 degrees 17 minutes West parallel with the said section line to the point of beginning.

PETITIONER STATES:

It is hereby requested by the sole property owner of the area proposed for annexation to annex certain property described herein lying in the Town of Moorhead to the City of Moorhead, County of Clay, Minnesota

The area proposed for annexation is described as follows:

A strip of land being the existing Right of Way of U.S. Highway 10, beginning at the Northwest Corner of Section 10, Township 139 North, Range 48 West of the Fifth Principle Meridian, Clay County, Minnesota; thence easterly, to the north Quarter Corner of Section 10, with the north line of said Right of Way being the south boundary of Eastgate First Addition and replat of Eastgate Second Addition; and with the south line of said Right of Way being the north boundary line of Gulling's Subdivision, together with the widened Right of Way within Gulling's Subdivision.

The above described Right of Way is also known as parcels 306, 307A and 307B as recorded in Book 22 Pages 207-213 of miscellaneous book on file with the office of Register of Deeds, Clay County Minnesota.
