M., Itasca County, Minnesota, is divided into parcels of irregular shape, which cannot be described except by metes and bounds, that on the 11th day of March, 1949, I, as Auditor duly requested the owners of said tracts of land, to-wit: Francis L. 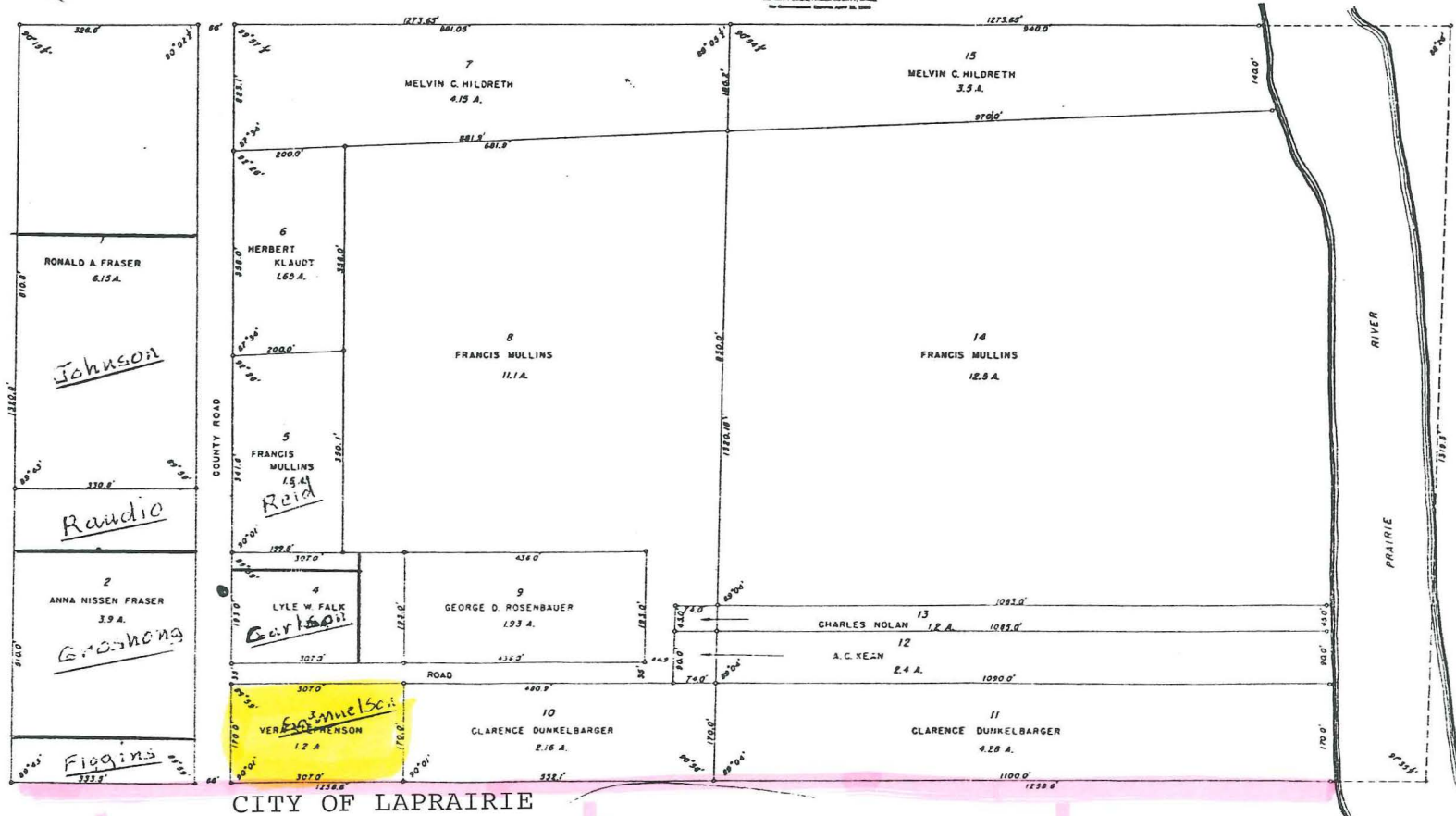

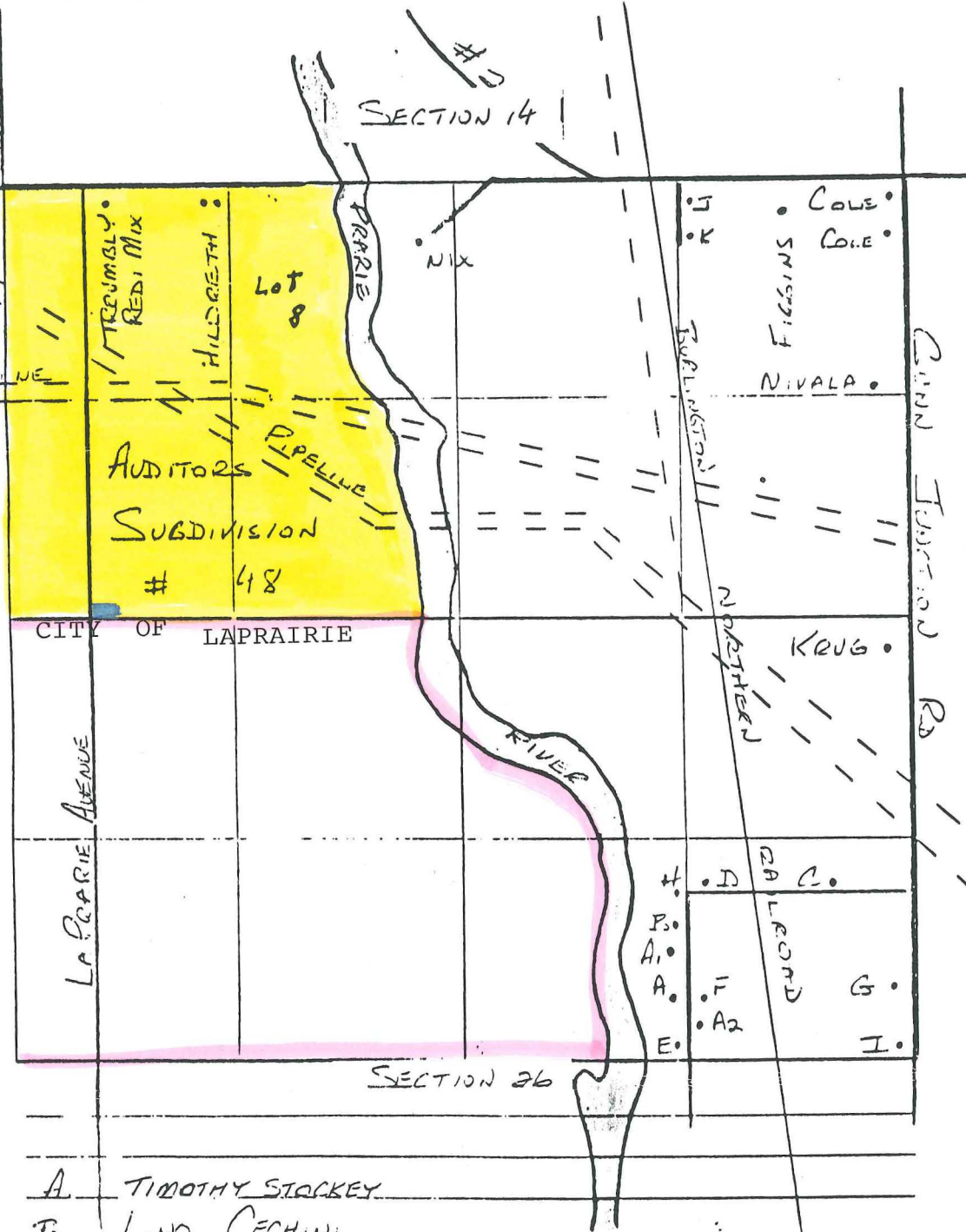

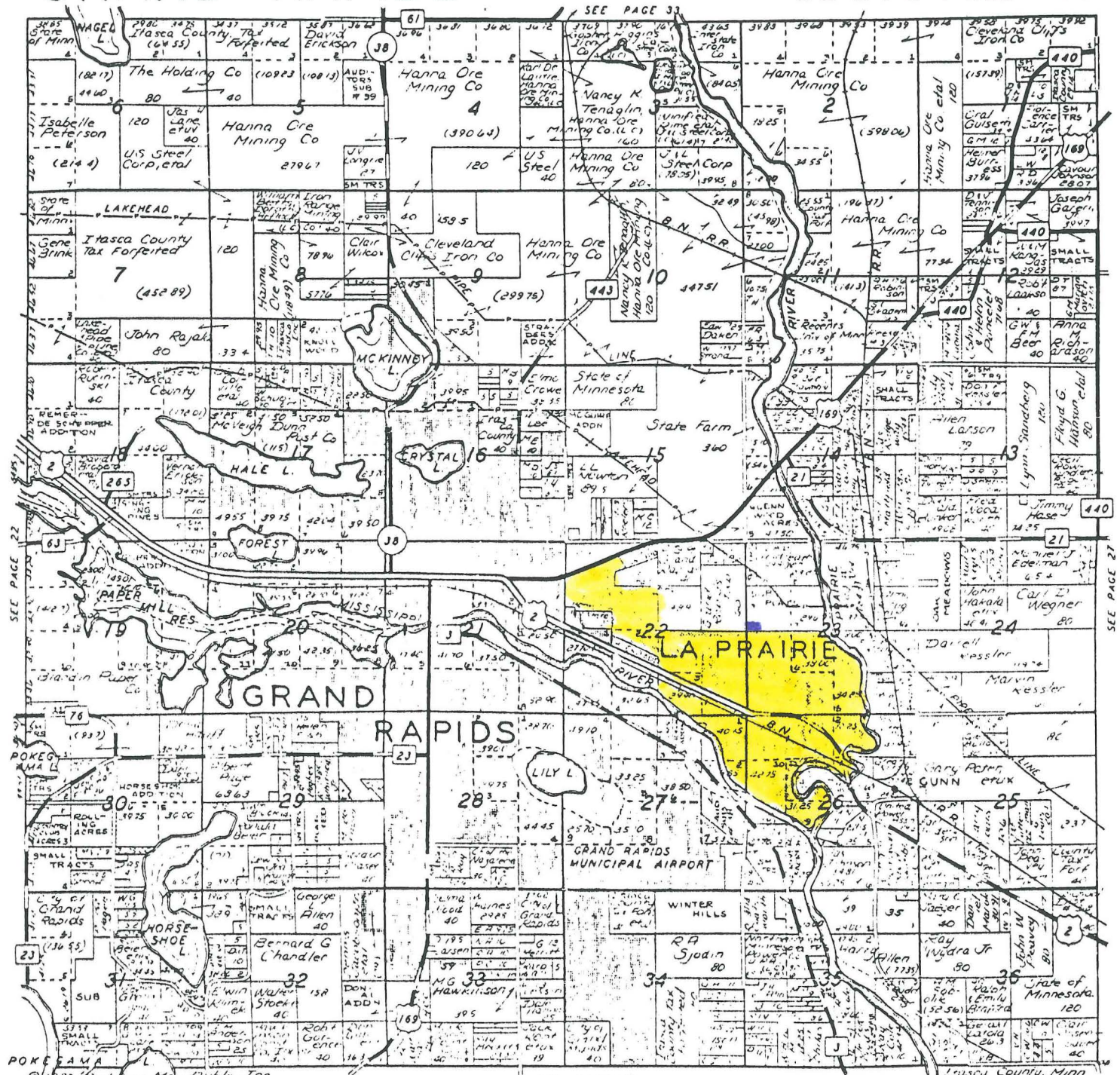
