

PETITION FOR ANNEXATION

TO: MUNICIPAL BOARD OF THE STATE OF MINNESOTA

ATTENTION: EXECUTIVE DIRECTOR

Affixed hereto, marked Exhibit "A," is certified copy of the Resolution of the Board of Independent School District #300, La Crescent (Houston County) Minnesota (District #300) petitioning for annexation of certain of its lands owned entirely and exclusively by District #300. Said District #300, for its Petition, respectfully states:

1. The lands, commonly called Abnet Field, the subject matter of this Petition for Annexation, a print, map or plat whereof is marked Exhibit "B" and hereto affixed, are described as follows, to-wit:

All that part of the North Half of the Northwest Quarter of Section 15, Township 104 North, Range 4 West of the Fifth Principal Meridian described as follows, to-wit: Commencing at the Northeast Corner of the Northwest Quarter of the Northwest Quarter of said Section 15, thence North 89°11' West along the North line of said Section 15, 60.0 feet, thence South 0°05'30" East 60.0 feet to an iron pipe, the point of beginning, thence North 89°11' West on a line parallel with the North line of said Section 15, 563.72 feet to an iron pipe on the Easterly line of the public roadway, thence South 23°37' East along the Easterly line of the public roadway 1091.56 feet to an iron pipe, thence North 87°05'30" East 128.07 feet to an iron pipe, thence South 89°11' East 192.0 feet to an iron pipe, thence North 0°05'30" West 580.54 feet to an iron pipe, thence North 89°11' West 192.0 feet to an iron pipe, thence North 0°05'30" West 405.0 feet to the point of beginning, containing 10.4 acres more or less.

3. The reasons for requesting annexation are to obtain City of La Crescent Municipal Sewer and Municipal Water Services, said property being contiguous to the existing corporate limits of the City, consists of approximately 10.4 acre(s), and is urban or about to be of urban character.

4. Affixed hereto, and marked Exhibit "C," is a certified copy of the Resolution of the City of La Crescent supporting the within Petition.



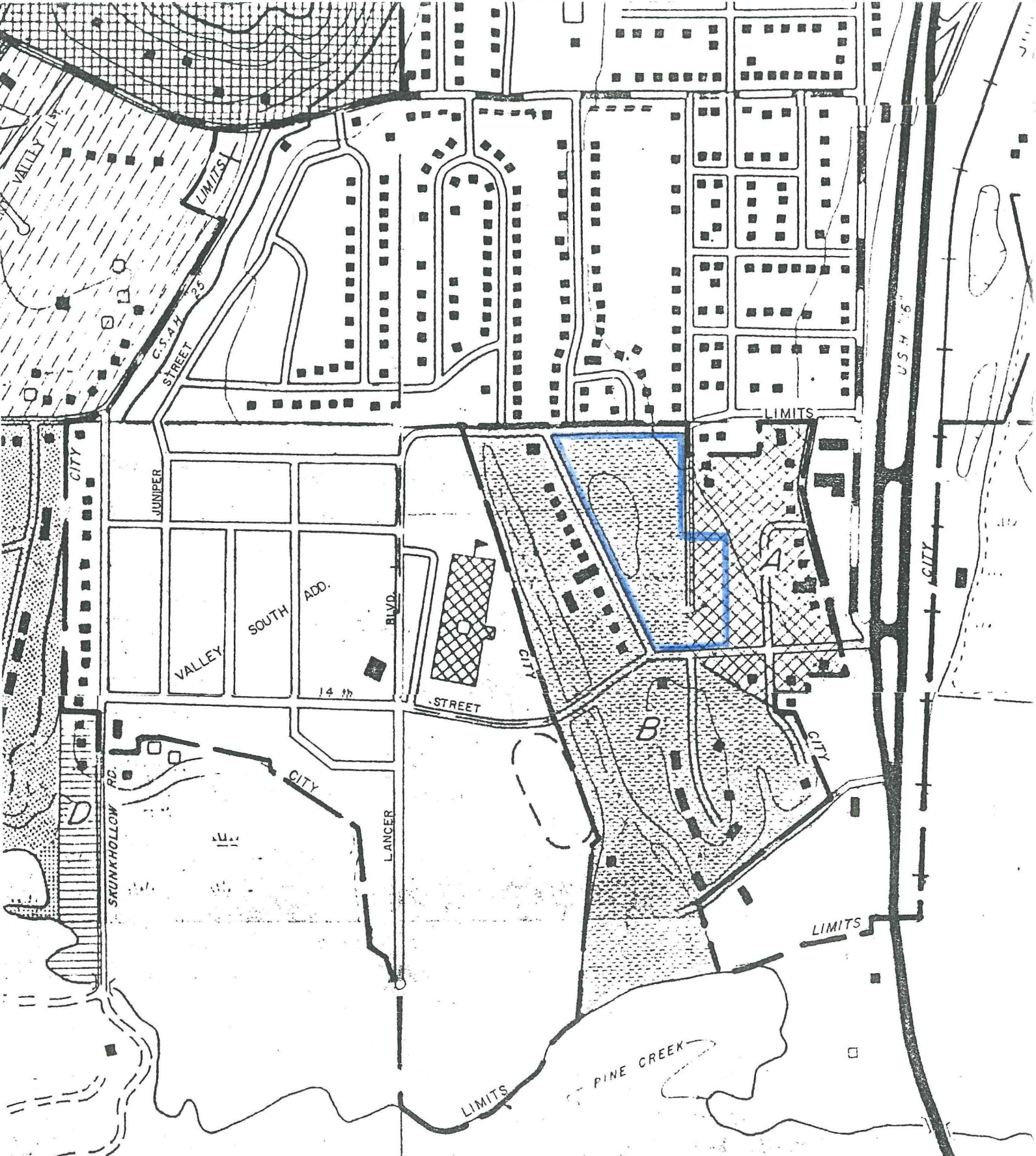

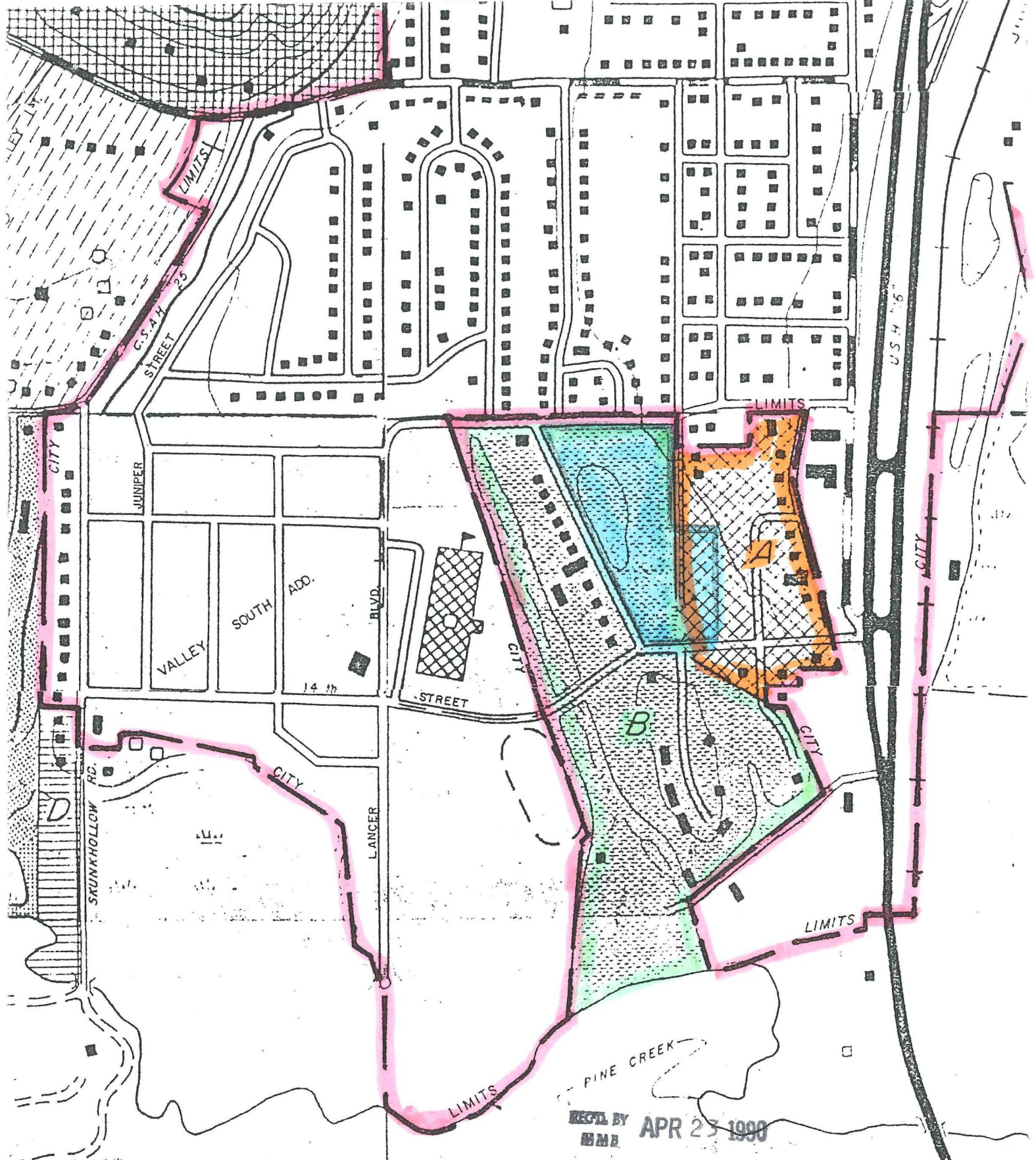


CITY LA CRESCENT & LA CRESCENT TOWNSHIP
