ORDINANCE NO. 595

AN ORDINANCE ANNEXING CERTAIN LANDS (JOHNSON-DEVELOPMENT CORP.) TO THE CITY OF WASECA, MINNESOTA AND ESTABLISHING THE ZONING THEREOF

WHEREAS, at the request of the landowners, certain lands are petitioned for annexation into the City of Waseca, and

WHEREAS, the land hereinafter described is unplatted land situated in Woodville Township, Waseca County, Minnesota, and is contiguous to the incorporated limits of the City of Waseca, and

WHEREAS, Woodville Township has waived any claim or appeal against said annexation petition, and

WHEREAS, said lands are urban or suburban in character or about to become urban or suburban in character, and

WHEREAS, the Waseca City Council has determined that the annexation of said land to the City of Waseca will be in the best interest of the City of Waseca.

NOW, THEREFORE, THE CITY OF WASECA DOES ORDAIN:

Sec. 1 That there is hereby annexed to and included within the City of Waseca, Minnesota, the following described land in the Count y of Waseca, State of Minnesota, as contained in Exhibit "A".

Sec. 2 That the annexed land shall be zoned within the meaning of the zoning ordinances and codes of the City of Waseca as I-1 Limited Industry.

Sec. 3 That a certified copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Secretary of the State of Minnesota, the Waseca County Auditor, the Waseca County Register of Deeds and the Clerk of the Woodville Township Board.

Sec. 4 That this ordinance shall be effective on upon legal publication, the filing of certified copies as directed in Sec. 3., and approval of the Minnesota Municipal Commission.
