Beginning 33 feet north of the northwest corner of the SW $\frac{1}{4}$ of Section 9, Township 102 North, Range 18 West, Mower County, Minnesota, this point being on the west line of said Section 9 and the north right-of-way line of 16th Avenue S.W. thence east along the north right-of-way of 16th Avenue S.W. 229.2' thence south on a line parallel to the west line of said Section 9 to the south right-of-way of said 16th Avenue S.W. this point also being on the north property line of Lot 1 of Hillier First Addition thence east on the north line of said Lot 1 to the northeast corner of said Lot 1 this point also being on the east line of Hillier First Addition thence south on the east line of Hillier First Addition to the northeast corner of Lot 8 Hillier First Addition thence west on the north line of said Lot 8 to the northwest corner of said Lot 8 thence south on the west line of said Lot 8 to the southwest corner of said Lot 8 thence easterly on the south line of said Lot 8 to the southeast corner of said Lot 8 this point also being on the east line of Hillier First Addition thence south on the east line of Hillier First Addition to the southeast corner of Lot 10 of said Hillier First Addition thence west on the south line of said Lot 10 to the southwest corner of said Lot 10 thence continuing west on a straight line to the southeast corner of Lot 11 of said Hillier First Addition thence north along the east line of Lot 11 and Lot 12 to the northeast corner of Lot 12 of said Hillier First Addition thence west on a straight line to the northwest corner of said Lot 12 this point also being on the west line of said Hillier First Addition thence north on said west line to the southwest corner of Lot 19 Hillier First Addition thence east on a straight line to the southeast corner of said Lot 19 thence north along the east line of Lot 19 and 20 of said Hillier First Addition to the northeast corner of said Lot 20 thence westerly on the north line of said Lot 20 to the northwest corner of said Lot 20 thence northerly on a straight line 66 feet to the point of beginning.
