The City of Motley, Minnesota.


The area proposed for annexation is described as follows:

Government Lot 4 of Section 19, Township 133 North, Range 31 West, Morrison County, Minnesota, together with abutting streets and highways (See attached Exhibit A).

1. The Petitioners have submitted a copy of this petition to the affected Township of Motley, Morrison County and Region 5.
2. The area proposed for annexation abuts the City on the southern boundary of the City and none of it is presently a part of any incorporated city or in an area designated for orderly annexation.
3. The total acreage of the area proposed for annexation is 40 acres.
4. The Petitioner believes that all of this property is or is about to become urban or suburban in character.
5. The reason for requesting the annexation is: That the property currently enjoys the benefits of City services including sewer and water services, police protection, fire protection through Motley fire department, economic development fund grants issued through City services.

6. The parties entitled to notice under Minnesota Statutes Section 414.09 include Motley Township, Morrison County, and Region V Development Commission.


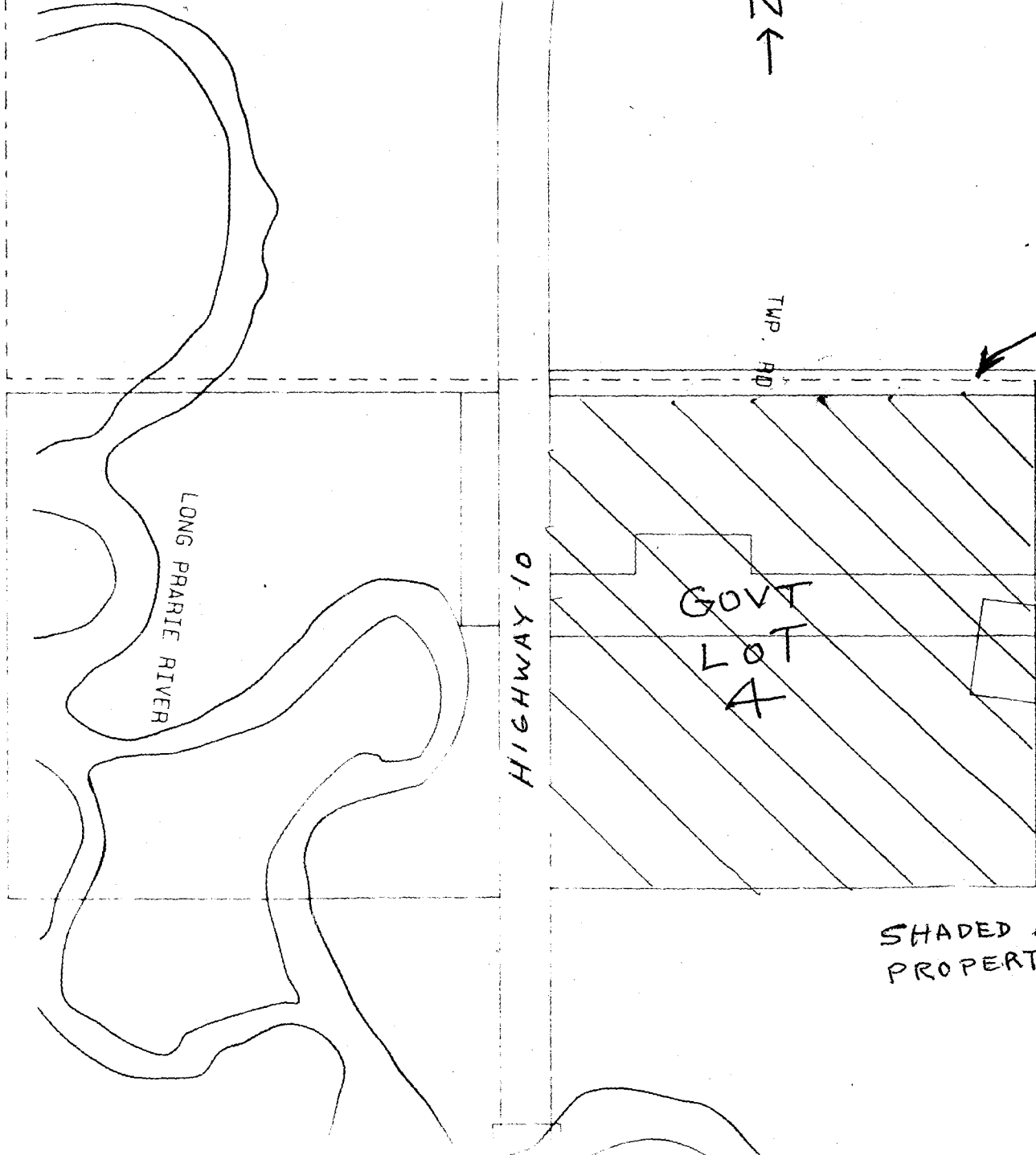
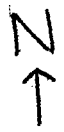
