## ORDINANCE NO. 91-2

AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED PROPERTY ABUTTING
THE CITY OF MOORHEAD AT THE SOUTHERLY BOUNDARY THEREOF
CONSISTING OF 11.81 ACRES A.K.A. INDEPENDENT SCHOOL
DISTRICT #152 PROPERTY ADJACENT TO RIVERVIEW ESTATES PARK.

WHEREAS, this Ordinance supercedes and replaces in its entirety Ordinance No. 90-20; and

WHEREAS, certain petitions requesting annexation of property hereinafter described were duly presented to the City Council of the City of Moorhead; and

WHEREAS, the quantity of the property described within the petitions is approximately 11.81 acres of unincorporated land; and

WHEREAS, the petitions were signed by all the property owners thereof; and

WHEREAS, the property described in the petition is bordered on its northerly and westerly sides by the City of Moorhead; and

WHEREAS, the Moorhead Planning Commission has favorably recommended to the City Council that said property be annexed by the City of Moorhead; and

WHEREAS, the City Council finds that the property proposed for annexation is now or is about to become urban in character and annexation of said property is required to protect the public health and safety and welfare, and annexation would be in the best interest of said property proposed for annexation;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moorhead as follows:

Section 1: The corporate limits of the City of Moorhead are hereby extended to include the following unincorporated plat of land:

## Independent School District #152 Property:

That part of the Southwest Quarter (SW\*) of Section Twenty (20), Township One Hundred Thirty-nine (139) North, Range Forty-eight (48), West, described as follows, to-wit: Beginning at a point which lies on the South line of Section 20, township 139 North, Range 48 West of the Fifth Principal Meridian, said point being located 809.33 feet West of the South One-Quarter corner in said Section 20, thence West along said South Section line a distance of 605.00 feet, thence North parallel to the North-South One-Quarter line in said Section 20, a distance of 850.00 feet; thence East parallel to the South line of said Section 20, a distance of 605.00 feet, thence South parallel to the aforementioned North-South One-Quarter line, a distance of 850.00 feet, more or less, to the Point of Beginning. Said tract of land contains 11.810 acres, more or less.

be and the same is hereby annexed to and included within the City pursuant to Minnesota Statute 414.033 as effectively as if it had originally been a part thereof.

Section 2: The City Clerk of the City of Moorhead is hereby directed to file with the Minnesota Municipal Board, the Township of Moorhead, Clay County Auditor and the Secretary of State certified copies of this Ordinance herein.

Section 3: This Ordinance shall take effect on the date said Ordinance is approved by the Minnesota Municipal Board. In no event shall this Ordinance take effect earlier than 30 days after publication in accordance with the Moorhead City Charter.
