

ORDINANCE NO. 95

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF REDWING TO INCLUDE CERTAIN UNINCORPORATED LAND ABUTTING UPON THE CITY LIMITS.

THE CITY COUNCIL OF THE CITY OF RED WING DO ORDAIN:

WHEREAS, a petition dated December 11, 1990, requesting annexation of the territory hereinafter described was duly presented to the council on December 17, 1990; and

WHEREAS, the petition was signed by all owners of said territory; and

WHEREAS, a resolution of waiver of objection to annexation, dated January 8, 1991, has been received from the Hay Creek town board, whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the southern boundary thereof;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RED WING DOES ORDAIN:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. The population of the territory is zero.

Section 3. Territory Annexed. The corporate limits of the city are hereby extended to include the land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

ID # 34-0000-05402 Pt of Gov Lot 4 Sec 6 112 14 Com at NE Cor of Lot 4, W alg N Line Lot 4 for 300 Ft, S 660 Ft, E 300 Ft, N alg E Line Lot 4 for 660 Ft to beg Ex N 50 Ft, which is 4.2 acres.

Section 4. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Hay Creek Town Clerk, and the Goodhue County Auditor.
