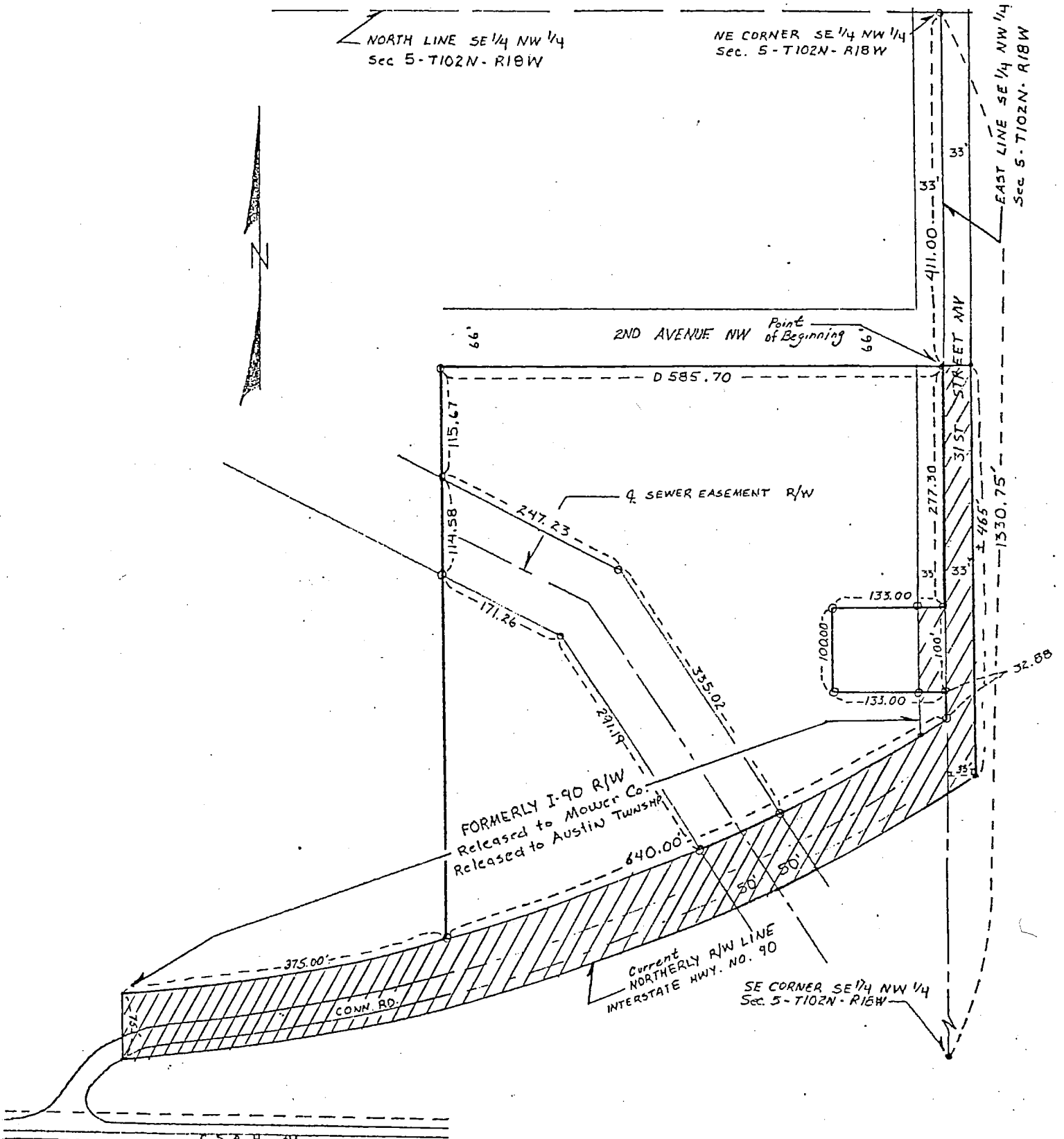

Road Right-of-Way Description
Existing Township Road
Connecting C.S.A.H. #46 to 31st St. NW
Proposed Annexation - Abutting City Limits

Commencing at a point on the East Line of the SE 1/4 of the NW 1/4 of Section 5, Township 102 North, Range 18 West, Mower County, Minnesota, which is 411.0 feet South of the Northeast Corner thereof, said point hereinafter called the Point of Beginning; thence South on said East Line of said SE 1/4 of the NW 1/4 of Section 5 a distance of 277.3 feet; thence West a distance of 33 feet; thence South on a line parallel with said East Line a distance of 100 feet; thence East a distance of 33 feet to a point on said East Line; thence South on said East Line a distance of 32.88 feet to a point on the North Right-of-Way Line of the former Interstate No. 90 Right-of-Way, released to Mower County Bk 369, Pg 153, and revoked to the Austin Township August 6, 1975; thence Southwesterly along said North Right-of-Way Line of the former Interstate No. 90 Right-of-Way (currently owned by the Austin Township) an approximate distance of 1015 feet; thence South a distance of 75 feet to a point on the current North Right-of-Way Line, Interstate Highway No. 90; thence Northeasterly along said current North Right-of-Way Line Interstate No. 90 to a point 33 feet East at a right angle to said East Line of said SE 1/4 of the NW 1/4 of Section 5; thence North on a line parallel with said East Line a distance of approximately 465 feet more or less; thence West a distance of 33 feet to the point of beginning.
