AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BARNESVILLE TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY

whereas, the territory described below in not presently within the corporate limits of any incorporated city: and

whereas, this territory abuts upon the corporate limits of the City at the north boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the city; The City Council of the City of Barnesville ordains:

Section 1. Territory annexed, The corporate limits of the City of Barnesville are hereby extended to include the unplatted property described as follows now owned by the City: From the Southeast Corner of Outlot 19c of Section 19, Township 137, North, Range 45 West; said Southeast corner being also the Southeast Corner of said Section 19; thence North along the East line of said Section 19, a distance of 75 feet, more or less, to a Point of intersection with the North Right of Way line of Truck Highway 34, said Point of intersection being the Point of Beginning of the tract of land therein described: thence North O degrees O minutes West along the East Line of said Rection 19, a distance of 859.25 feet; thence South 89 degrees 30 minutes West a distance of i329.60 feet; thence South O degrees 44 minutes East a distance of 650.47 feet, more or less, to a Point of Intersection with the North Right of Way Line of Trunk Highway 34; thence Southeasterly along said North Right of Way Line to the point of beginning; less that part of Outlot 19A of said Section 19 which is located within the lines described in the aforementioned maragraph; and less the Easterly 33 feet of said tract, which is reserved for o road easement parallel to the East line of said Section 19.

baid tract of land contains 22.344 acres, more or less.

Section 2. Filling. The City Clerk is directed to file certified copies or this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township, and the Minnesota Municipal Board.

Section 3 Effective date of annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
