ORDINANCE NO. 1991- 4

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE
CITY OF APPLETON, MINNESOTA TO INCLUDE CERTAIN
UNINCORPORATED UNPLATTED LAND NOT EXCEEDING
200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a Petition dated May 7, 1991, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 10th day of July, 1991; and

WHEREAS, the quantity of land embraced within the area described in the Petition is 2.51 acres of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the Petition was signed by all owners; and

WHEREAS, no objection to the Annexation has been received from the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and no objection being received from the Town Board and such Appleton Town Board waiving the 90-day period to object by resolution dated June 3, 1991; and

WHEREAS, the land described in the Petition abuts upon the City Limits, the City of Appleton, Minnesota, ordains

Section 1: The City Council hereby determines that:

1. The annexation will be in the best interest of the City and of the territory affected;
2. That the territory described herein abuts upon the City Limits and is about to become urban or suburban in character; and
3. That none of said territory is now included within the limits of any city, village or borough.

Section 2: Territory Annexed

1. The corporate limits of the City of Appleton are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The West 370' of the South 295' of the SW1/4-SW1/4, Section 11, Township 120, Range 43, Swift County, Minnesota, containing 2.51 acres, more or less.

1. The City Clerk is hereby directed to file certified copies of the ordinance with the Minnesota Municipal Board, the Secretary of State, County Auditor and the Town Clerk.

Section 4: Effective Date

1. This Ordinance takes effect upon its passage and publication and upon the approval of the Minnesota Municipal Board and the filing of the certified copies as directed in Section 3.
