AGREEMENT TO WITHDRAW OBJECTION AND PERMIT ANNEXATION

This Agreement is entered into this 10th day of September, 1991, by and between the City of Holdingford and Holding Township. The undersigned, Boniface Stoermann, Mayor of the City of Holdingford, has executed this Agreement pursuant to the authority granted and at the direction of the Holdingford City Council pursuant to action taken at the City Council's regular meeting held on September 9, 1991, and the undersigned, Mark Kociemba, Chairperson of the Town Board of Holding Township, has executed this Agreement at the direction of the Board of Supervisors of Holding Township.

WHEREAS, Holding Township filed objections to the annexation of certain real estate dated July 8, 1991, pursuant to action taken on July 2, 1991, relating to that certain real estate described as follows, to-wit:

The South One Hundred Thirty (130) feet of Lot Numbered One (1) Auditor's Subdivision Number Thirteen (13), Township of Holding, Stearns County, Minnesota, and

The East Half of Lot Numbered Two (2) of Auditor's Subdivision Numbered Thirteen (13) according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for said County and State.

Referenced as Minnesota Municipal Board Docket Number A-4854.

Said real estate is owned by Vernon H. Voss and Delores Voss.

WHEREAS, after due and careful consideration and negotiations between the City and the Township, it is mutually agreed between the City and the Township that the Township hereby withdraws the objection referenced above and will permit the annexation of the Voss real estate described above to the City of Holdingford, State of Minnesota, without further action by the City and/or the Municipal Board.

IT IS FURTHER AGREED by and between the parties hereto that the hearing set for September 18, 1991, in the City of Holdingford, to be conducted by the Minnesota Municipal Board relative to the objections
