DESCRIPTION FOR ANNEXATION PURPOSES ONLY
IN N 1/2 SE 1/4 SECTION 9-T102N-R18W

HENRY LIGHTLEY

All that part of the N 1/2 SE 1/4 Section 9-T102N-R18W, described as follows:

Commencing at the northeast corner of said N 1/2 SE 1/4 Section 9-T102N-R18W, thence West a distance of 170.00 feet, on the north line of said SE 1/4, to the point of beginning;

thence West a distance of 1480 feet more or less, on the north line of said SE 1/4, to the northeast corner of Block 9, in the Plat of Austin Homesteads, as the same is platted and recorded in the Office of the County Recorder of Mower County, Minnesota;

thence South a distance of 1053.3 feet, on the east line of said Block 9, Austin Homesteads, to the southeast corner thereof;

thence East a distance of 143.3 feet more or less, to the northwest corner of Block 1, Southgate Second Addition as the same is platted and recorded in the Office of the County Recorder of Mower County, Minnesota;

thence East a distance of 681.7 feet, on the north line of said Southgate Second Addition to a point 825 feet west of the northeast corner thereof.

thence North a distance of 528 feet, on a line parallel with the east line of said SE 1/4 Section 9-T102N-R18W;

thence East a distance of 825 feet, to a point on the east line of said SE 1/4;

thence North a distance of North 271.5 feet, on the east line of said SE 1/4, to a point 257.0 feet South of the northeast corner thereof;

thence West a distance of 170.0 feet, on a line parallel with the north line of said SE 1/4;

thence North a distance of 257.00 feet, to the point of beginning;

Commencing at the southwest corner of Outlot 8, located in the NE 1/4 Section 9-T102N-R18W;

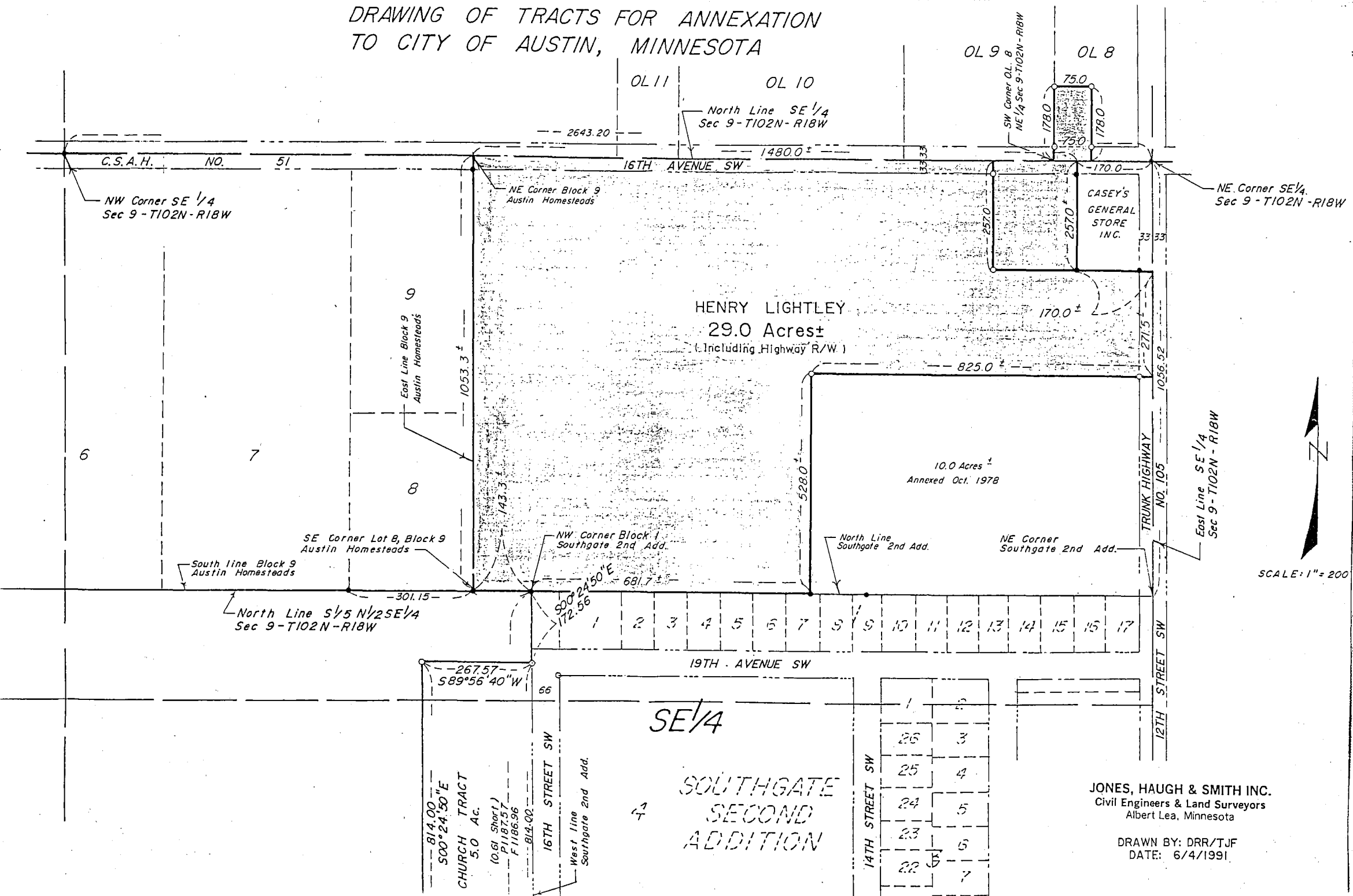
thence North a distance of 178 feet, on the West line of said Outlot 8;
