The North Half (N $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty-four (34), Township One Hundred Forty (140), Range Forty-eight (48), Clay County, Minnesota

1. There is one property owner in the area proposed for annexation.
2. The sole property owner has signed this petition.
3. The population of the annexation area is zero.
4. Said property is unincorporated, abuts on the City's east boundary, and is not included within any other municipality.
5. The area of land to be annexed in acres is:

6. The reason for the requested annexation is: for construction of water treatment sludge ponds.
7. All of the annexation area is or is about to become urban or suburban in character.

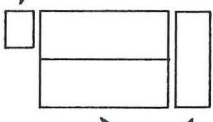
