

ORDINANCE NO. 2252

AN ORDINANCE ANNEXING TO THE CITY OF ROCHESTER A PORTION OF THE NORTHEAST QUARTER OF SECTION 4, TOWNSHIP 106 NORTH, RANGE 14 WEST.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The Common Council of the City of Rochester has initiated the annexation of the following described lands located in Olmsted County, Minnesota:

That part of the Northeast Quarter of Section 4, Township 106 North, Range 14 West, Olmsted County, Minnesota, according to the plat thereof on file at the County Recorder's Office, Olmsted County, Minnesota, described as follows:

East 200 feet North 100 feet of Lot 8 of Hillcrest Subdivision (305 Highland Ct. S.W.); and

East 133 feet North 100 feet of Lot 8 of Hillcrest Subdivision (307 Highland Ct. S.W.).

Section 2. The quantity of land included in said petition is approximately 33,300 square feet of platted land.

Section 3. The Common Council of the City of Rochester does hereby determine that the land described in Section 1 is surrounded by land owned by the City of Rochester, is urban or suburban in character, or about to become so, and is so conditioned as to be properly subjected to municipal government, and the annexation of said land will be in the best interest of the City of Rochester and the land described.

Section 4. Therefore, the land described in Section 1 above is hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal board, the Rochester Town Clerk, the County Auditor, and the Secretary of State.

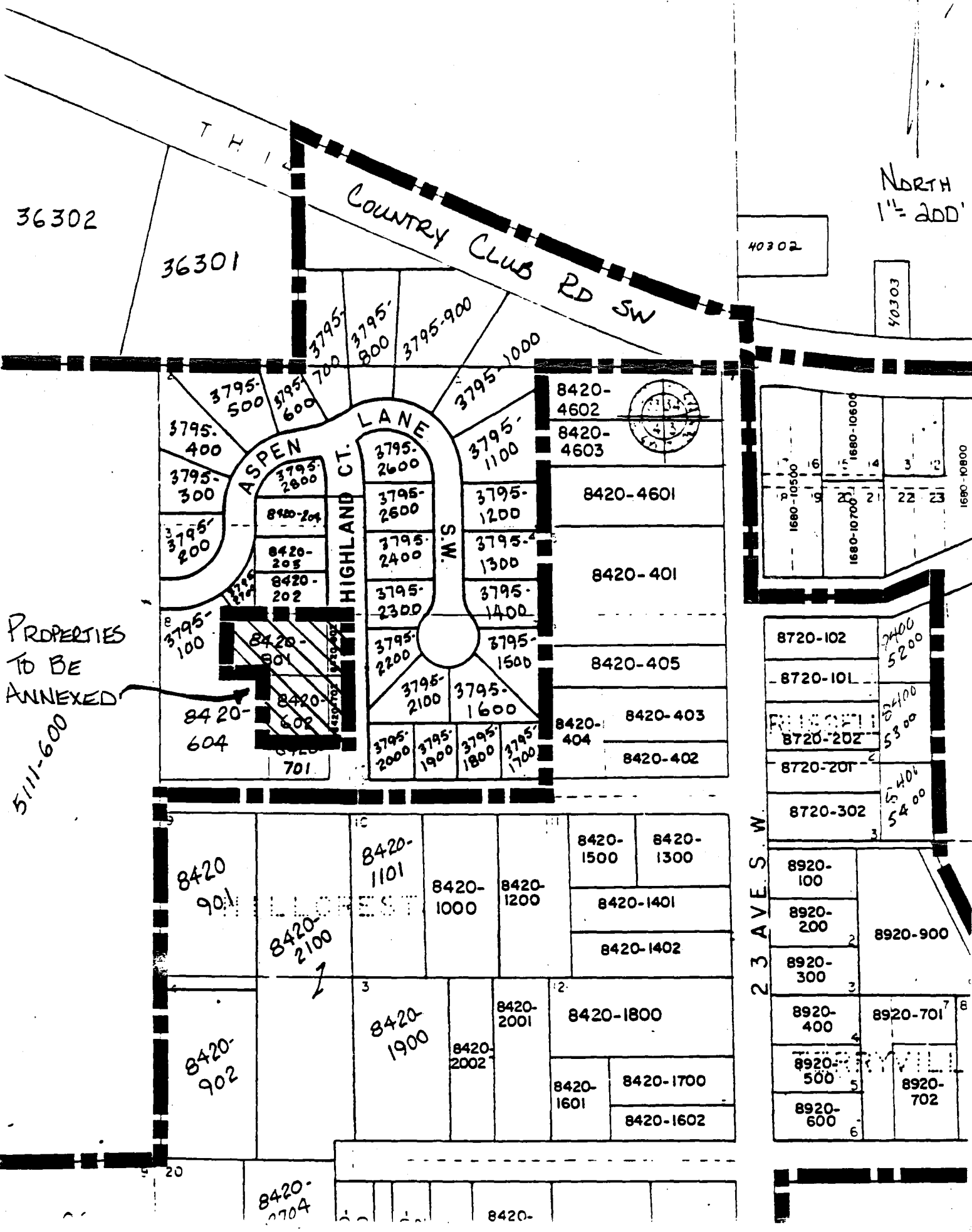
