ORDINANCE ANNEXING PROPERTY TO THE CORPORATE LIMITS OF THE CITY OF MANKATO

WHEREAS, certain property described below is not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, said described property is owned by the City of Mankato, which operates the Mankato Municipal Airport on such described property; and

WHEREAS, the City of Mankato is responsible for management and operation of the airport; and

WHEREAS, the City of Mankato provides police and fire service for the airport lands; and

WHEREAS, the population of the area to be annexed is four with the number of residential structures being one.

WHEREAS, the Council of the City of Mankato deems it appropriate for the City of Mankato to have full authority over the airport land for which it is responsible; and

WHEREAS, the Legislature of the State of Minnesota has adopted Chapter 82 of 1991 Session Laws authorizing the City of Mankato to adopt by ordinance non-contiguous property owned by the City of Mankato which constitutes the Mankato Municipal Airport. Said legislation signed by the governor on 13 May, 1991; and

WHEREAS, on the 9th day of September, 1991, said Mankato City Council did pass a resolution approving such legislation pursuant to Minnesota Statute 645.021, Subd. 3.

NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the corporate limits of the City of Mankato are hereby extended to include the land described in Attachment A, and the same is hereby annexed to and included within the City of Mankato as effectively as if it had been a part thereof.

The City Clerk is hereby directed to file copies of the Ordinance with the Minnesota Municipal Board, the Blue Earth County Auditor, the Le Sueur County Auditor, the Lime Township Board, and the Kasota Town Board.

This ordinance shall take effect thirty (30) days after its passage, due publication thereof, and approval by the Minnesota Municipal Board.
