

**WAIVER OF 90-DAY
WAITING PERIOD FOR ANNEXATION**

The Town Board of Town of Moorhead received an annexation petition for the following described land in Moorhead Township:

That part of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty (20), Township One Hundred Thirty-nine (139) North, Range Forty-eight (48) West, described as follows: Beginning at the South Quarter corner (S $\frac{1}{4}$) between Sections 20 and 29; thence west along the section line common to Sections 20 and 29 a distance of 809.33 feet; thence north parallel to the east boundary of said quarter section 633 feet; thence east parallel to the south boundary of said quarter section 809.33 feet; thence south to the point of beginning. Said tract contains 11.76 acres, more or less.

The Township Board is aware that the City of Moorhead intends to grant the petitioners request and annex the property herein described. In order to expedite this annexation, the Township Board has approved a resolution stating they have no objection to the annexation and that they waive the 90-day waiting period.

WAIVER OF 90-DAY
WAITING PERIOD FOR ANNEXATION

The Town Board of Town of Moorhead received an annexation petition for the following described land in Moorhead Township:

A tract of land located in the Southeast Quarter of the Southwest Quarter of Section 20, Township 139 North, Range 48 West of the Fifth Principal Meridian, Clay County, Minnesota, described as follows: Commencing at the Southeast Corner of Said Southwest Quarter; thence on an assumed bearing of North 00 degrees 00 minutes 00 seconds West along the east line of said Southwest Quarter 752.00 feet to the point of beginning; thence North 89 degrees 33 minutes 41 seconds West 809.30 feet; thence South 00 degrees 00 minutes 00 seconds East 119.00 feet; thence South 89 degrees 33 minutes 41 seconds East 809.33 feet to a point on the east line of said Southwest Quarter; thence North 00 degrees 00 minutes 00 seconds West along the east line of said Southwest Quarter 119.00 feet to the point of beginning; said tract contains 2.21 acres more or less.
