WHEREAS, said ordinance contains a typographical error in the legal description of that ordinance, and;

WHEREAS, the legal description as contained in the ordinance should have indicated an exception of the Southerly Five Hundred Thirty feet (S'ly 530 feet), as opposed to the Southerly Five Hundred Fifty feet (S'ly 550 ft.)

NOW THEREFORE, the legal description as contained in that ordinance is amended as follows:

The Easterly Three Hundred Thirty feet (E'ly 330 ft.) of the Southeast Quarter

of the Southwest Quarter (SE 1/4 of SW 1/4) except the Easterly Thirty-three
