## AN ORDINANCE AMENDING ORDINANCE NO. 101392-204

THE CITY COUNCIL OF FLOODWOOD, MINNESOTA ORDAINS AS FOLLOWS;

WHEREAS, Ordinance No. 101392-204 was passed by the City Council of Floodwood, Minnesota on October 13, 1992, and;

WHEREAS, said ordinance contains a typographical error in the legal description of that ordinance, and;

WHEREAS, the legal description as contained in the ordinance should have indicated an exception of the Southerly Five Hundred Thirty feet (S'y 530 feet), as opposed to the Southerly Five Hundred Fifty feet (S'y 550 ft.)

NOW THEREFORE, the legal description as contained in that ordinance is amended as follows:

The Easterly Three Hundred Thirty feet (E'y 330 ft.) of the Southeast Quarter of the Southwest Quarter (SE 1/4 of SW 1/4) except the Easterly Thirty-three feet (E'y 33 ft.) thereof for roadway and except the Northerly Four Hundred Fifty-eight feet (N'y 458 ft.) thereof, and except the Southerly Five Hundred ~~Thirty~~ Thirty feet (S'y ~~530~~ 530 ft) thereof, Section Six (6) Township Fifty-one (51) North of Range Twenty (20) West of the Fourth Principal Meridian.

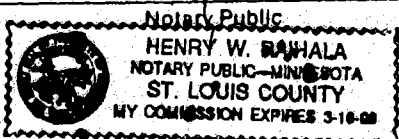

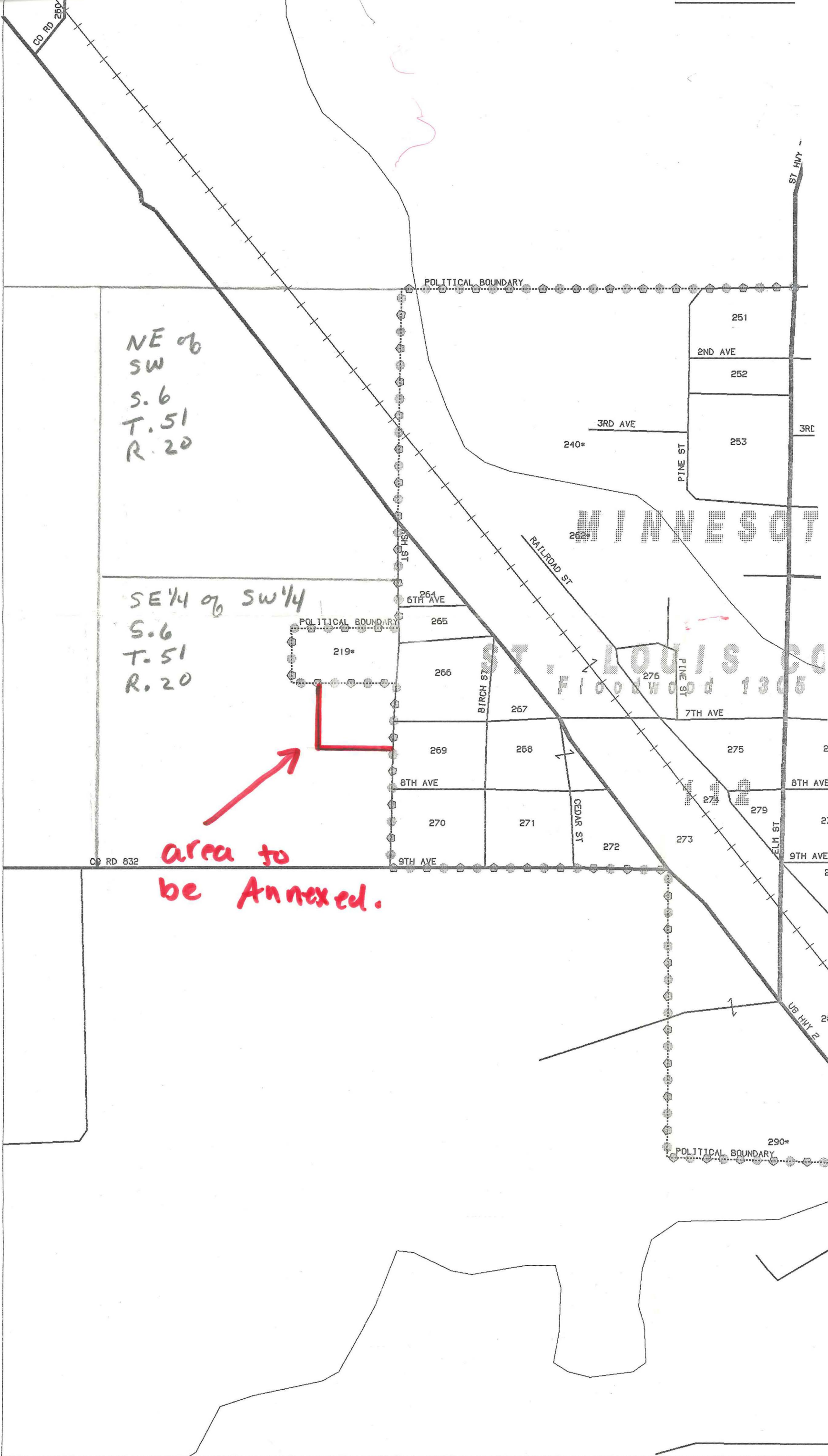
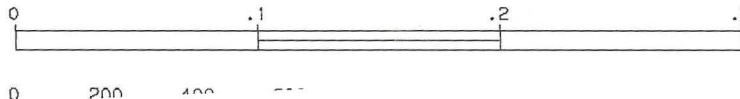
