AN ORDINANCE RELATING TO THE ANNEXATION
TO THE CITY OF FREEBORN OF CERTAIN LANDS SITUATED IN FREEBORN
TOWNSHIP, FREEBORN COUNTY, MINNESOTA

The City of Freeborn does ordain:


