#### ORDINANCE NO. 66

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF TOWER TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

The City of Tower Ordains:

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated City; and

WHEREAS, the territory abuts upon the corporate limits of the City of Tower and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the City; and

WHEREAS, Minnesota Statutes 414.033 provides for a process of annexation by ordinance; The City Council of Tower ordains;

# SECTION ONE TERRITORY ANNEXED

The corporate limits of the City of Tower are hereby extended to include the property described on attached Exhibit "A", now owned by the City.

### SECTION TWO FILING

The City clerk is directed to file certified copies of the \Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected Township and the Minnesota Municipal Board.

## SECTION THREE EFFECTIVE DATE OF ANNEXATION

This Ordinance takes effect upon its passage and publication, the filing of certified copies as directed in Section Two and upon the approval of the State Municipal Board as provided in Minnesota Statutes 414.033, Subdivision 7.
