ORDINANCE NO. <u>141</u>

THIRD SERIES

AN ORDINANCE TO ANNEX CERTAIN UNINCORPORATED LAND SURROUNDED BY THE RED WING CITY LIMITS.

THE CITY COUNCIL OF THE CITY OF RED WING DOES ORDAIN:

WHEREAS, certain unincorporated property is not currently included within the Red Wing corporate limits but is completely surrounded by the City of Red Wing; and

WHEREAS, Minnesota Statutes, §414.033 allows for the annexation of this property by ordinance.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RED WING DOES ORDAIN:

Section 1. The city council hereby determines (1) that the territory described herein is surrounded by the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any incorporated city.

Section 2. The population of the territory is $\frac{6}{6}$.

Section 3. The corporate limits of the city are hereby extended to include the land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof, to wit:

See Exhibit "A" attached hereto.

Section 4. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the <u>Hay Creek</u> Town Clerk, and the Goodhue County Auditor.

Section 5. <u>Effective Date</u>. This ordinance shall be effective upon its passage and publication, or upon approval by the Municipal Board, whichever is later.


