ORDINANCE #688

AN ORDINANCE ANNEXING TO THE CITY
OF KASSON, MINNESOTA, CERTAIN UNPLATTED
LAND NOT EXCEEDING 200 ACRES IN AREA,
ALL BEING IN SECTION 28, TOWNSHIP 107
NORTH, RANGE 16 WEST, DODGE COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF KASSON, MINNESOTA, DOES ORDAIN:

Section I. A petition has been filed with the City Council of the City of Kasson, signed by all owners of the land described herein, requesting the City Council to annex said land to the City of Kasson. The land described in said petition for annexation is located in Mantorville Township, Dodge County, Minnesota, described as follows:

Parcel #1

Commencing at the center of Section Twenty-eight (28), Township One Hundred Seven (107) North of Range Sixteen (16) West thence running in an Easterly direction Two Thousand Six Hundred Thirty-nine (2,639) feet to the quarter corner and thence running Northerly along the Easterly boundary of said section a distance Eight Hundred Sixty-six and Twenty-five One Hundredths (866.25) feet to a point and thence running Westerly Two Thousand Six Hundred Thirty-nine (2,639) feet to a point and thence running Southerly Eight Hundred Sixty-six and Twenty-five One hundredths (866.25) feet to a place beginning, containing Fifty-two (52) acres more or less. Constitutes the school property.

Parcel #2

That part of Northeast Quarter of Section 28, Township 107 North, Range 16 West, Dodge County, Minnesota, described as follows: Commencing at the Southwest corner of the Northeast Quarter of said Section 28; thence North, assumed bearing along the West line of said Northeast Quarter, 1236.66 feet; thence North 89 degrees 04 minutes 00 seconds East, 210.20 feet; thence South, 50.00 feet; thence East, 150.00 feet; thence South 45.20 feet for the point of beginning; thence continue South, 64.80 feet; thence East, 80.00 feet; thence South, 215.00 feet to the North line of the South 866.25 feet of said Northeast Quarter; thence South 89 degrees; 50 minutes 25 seconds East, along said North line, 292.85 feet, thence North, 280.62 feet; thence West, 372.85 feet to the point of beginning. Containing 2.0 acres more or less. Known as the church property.

A part of the Northeast Quarter of Section 28, Township 107 North, Range 16 West, described by metes and bounds as follows: Beginning at a point on the West line of said quarter section which is 866.6 feet North of the Southwest corner thereof, thence North along said West line a distance of 370.0 feet, thence East at a deflection angle of 89 degrees 04 minutes to the right a distance of 210.2 feet, thence South parallel to said West line a distance of 50.0 feet, thence East at right angles to the previous course a distance of 150.0 feet, thence South at right angles a distance of 110.0 feet, thence East at right angles a distance of 80.0 feet, thence South at right angles a distance of 213.0 feet, thence West at right angles a distance of 440.0 feet to the place of beginning. Being subject to the rights of the State of Minnesota on that portion being used for highway purposes. Contains 3.2 acres more or less.

Section 2. The quantity of unplatted land so described in said petition is approximately 57.2 acres more or less.

Section 3. The City Council of the City of Kasson does hereby determine that the land described in Section 28, Township 107 North, Range 16 West, abuts upon the present territorial limits of the City of Kasson, is so conditioned as to be properly subjected to municipal government and the annexation of said land will be in the best interest of the City of Kasson and the land affected.

Section 4. Therefore, the land described in Section 28, Township 107 North, Range 16 West herein, is hereby annexed, added to and made a part of the City of Kasson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the City Council to assess against said annexed property, all or a portion of the cost of any water lines, trunk line sanitary sewer, service connections and street construction, heretofore or thereafter undertaken to serve the area annexed.

Section 6. Present and future owners of the area annexed by this ordinance are hereby notified that it is the intention of the City Council to provide adequate, routine police protection and patrol of the premises and to respond to all emergencies. If, however, an officer is required to be present at specific school and/or church functions, Independent School District #204 and/or Holy Family Catholic Church shall hire a licensed officer at their expense.

<u>Section 7.</u> Pursuant to Article 1 - Section 1.05 of Ordinance No. 523 known as the Zoning Ordinance of the City of Kasson, Minnesota, the lands herein annexed to the City of Kasson shall be designated as <u>Residential R-1</u>.

Section 8. This ordinance shall take effect and be in force from and after its offical publication and from and after the filing of a Certified Copy hereof with the Minnesota Municipal Board, the Mantorville Township Clerk, the Dodge County Auditor and the Secretary of State.
