Councilmember *Roland Beckering* introduced the following ordinance and moved for its adoption:

ORDINANCE NO. 11-3-93

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF EDGERTON TO INCLUDE CERTAIN LAND
OWNED BY THE CITY OF EDGERTON AND ABUTTING
THE CITY LIMITS OF EDGERTON
(S.1353 FT OF THE W1/2NE1/4-21-105-44, LESS 66 FT THEREOF)

WHEREAS, the City of Edgerton is the legal owner of the following described property:

The South Thirteen Hundred Fifty-three (1353) Feet of the West Half of the Northeast Quarter (W1/2NE1/4) of Section Twenty-one (21) in Township One Hundred Five (105) North of Range Forty-four (44) West of the 5th P.M., except the South Sixty-six (66) Feet thereof, in Pipestone County, Minnesota, containing 39 acres, more or less.

and;

WHEREAS, the City of Edgerton is the sole owner of the property, the property is unincorporated, abuts the limits of the City of Edgerton, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, and is approximately 39 acres in size.

NOW THEREFORE, the City Council of Edgerton, Minnesota, does hereby ordain:

Section 1. The City Council hereby determines and finds that the property abuts the municipality, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, that the municipality is the sole owner of the property to be annexed, and that all of the provisions of Minnesota Statute 414.033 have been complied with.

Section 2. The property is urban in nature or about to become so.

Section 3. The corporate limits of the City of Edgerton are hereby extended to include the property and the same are hereby annexed to and included within the City of Edgerton as if the property had originally been a part thereof.

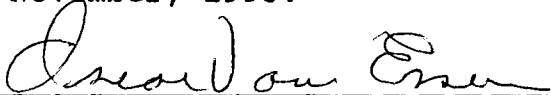

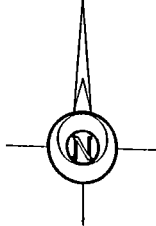

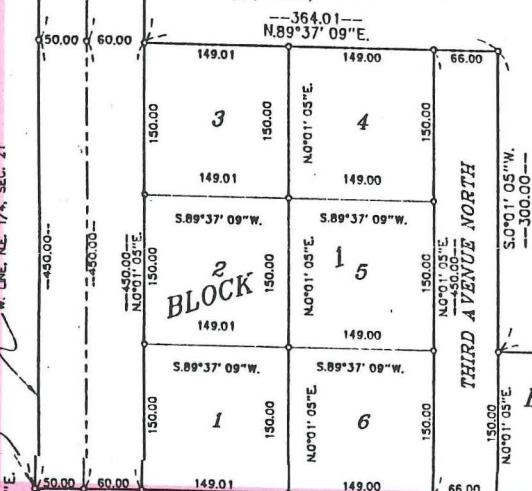

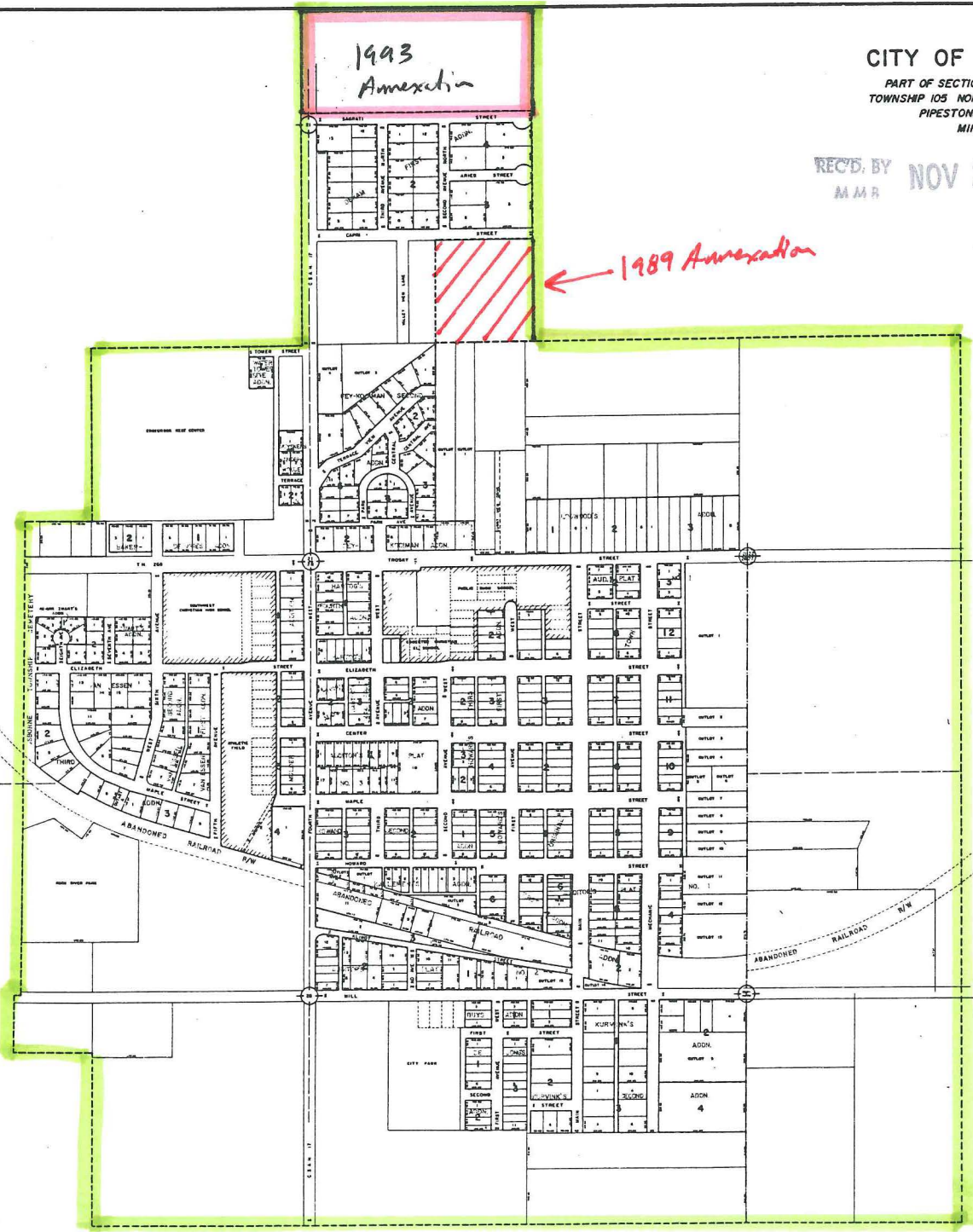

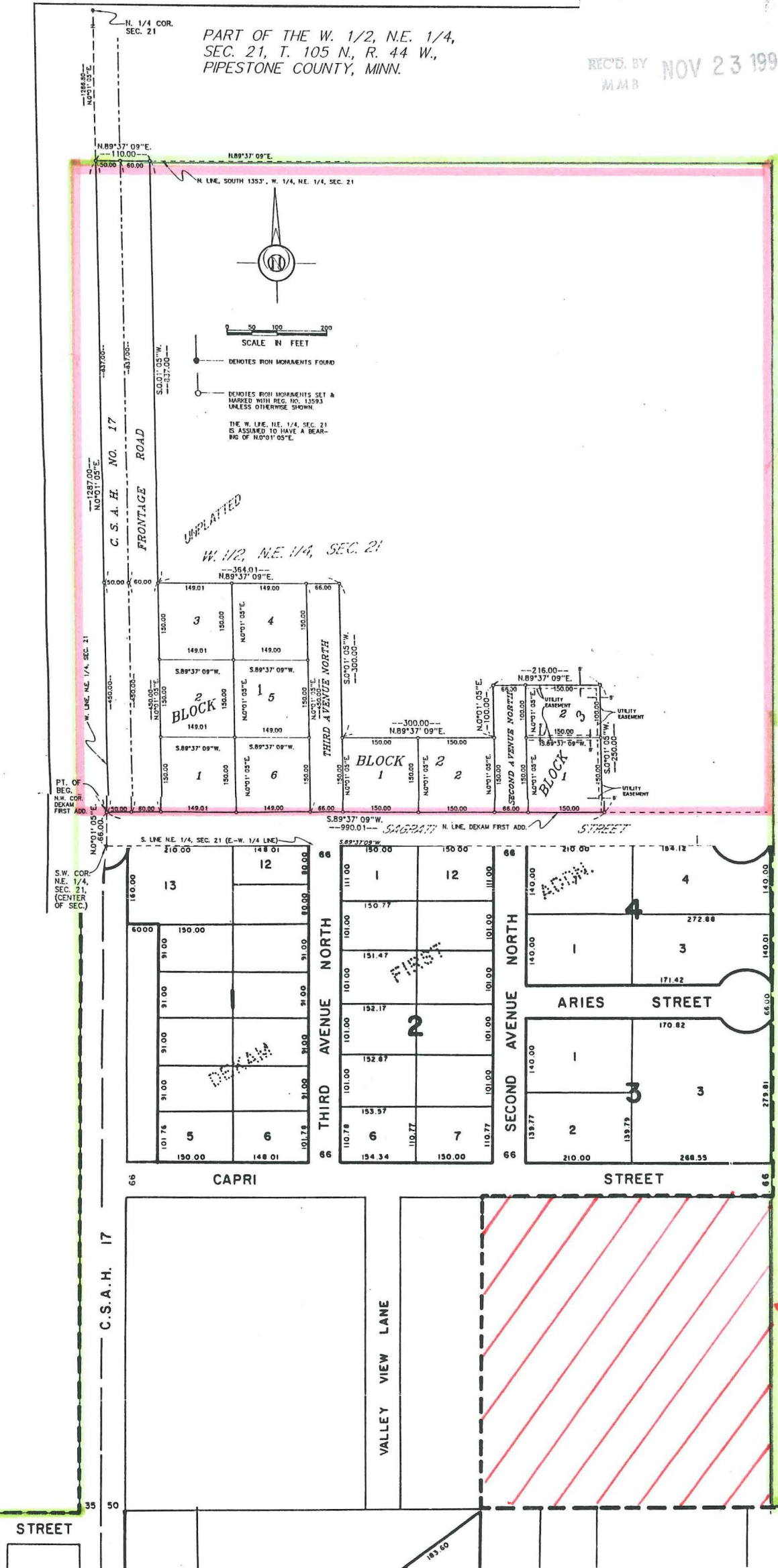
