AN ORDINANCE ANNEXING CERTAIN
PROPERTIES TO THE CITY OF ALEXANDRIA

The City of Alexandria does ORDAIN:

SECTION I. That as a result of petition for annexation submitted by an owner of real estate described therein, which lands abut the City of Alexandria and the subject area is less than 60 acres, the City of Alexandria is permitted to annex the lands by ordinance pursuant to Minn. Stat. 414.033, Subd. 2(3), and inasmuch as the utility data requirement does not apply to this property,

IT IS HEREBY ORDAINED that the land described on Attachment #1 shall be annexed to the City of Alexandria.


SECTION II. This ordinance shall be in full force and effect from and after its passage, publication, and filing with the Minnesota Municipal Board.



thence South 89 degrees 36 minutes 51 seconds West 1296.80 feet to the point of beginning.

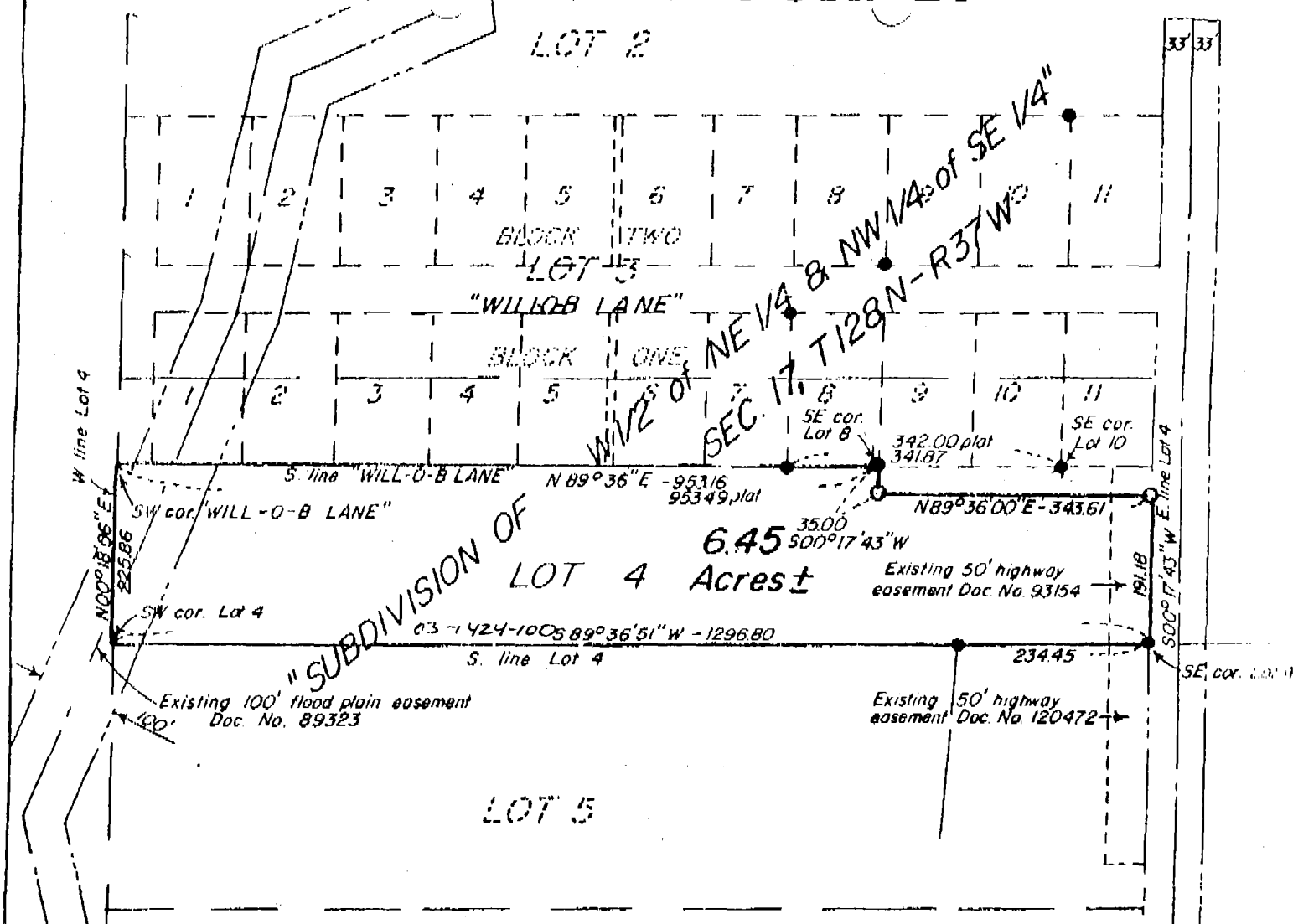
