ORDINANCE NO. 904.00

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WARROAD, MINNESOTA, TO INCLUDE LAND NOT EXCEEDING SIXTY (60) ACRES IN AREA AND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated October 18, 1993, requesting annexation of the territory hereinafter described was duly presented to the City Council of the City of Warroad, Minnesota, on the 25th day of October, 1993; and

WHEREAS, the Petition was signed by the sole owner; and

WHEREAS, the land described in the Petition abuts upon the city limits of the City of Warroad at the westerly boundary;

The Council of the City of Warroad, Minnesota, ordains:

SECTION 1. Council Findings. The City Council hereby determines that the annexation will be in the best interest of the city and of the territory affected; that the territory herein abuts upon the city limits and is about to become urban or suburban in character, and that none of said territory is now included within the limits of any city.

SECTION 2. Population. The population of the territory is zero (0).

SECTION 3. Territory Annexed. The corporate limits of the City of Warroad are hereby extended to include the land described as follows and the same is hereby annexed to and


included within the city as effectually as if it had originally been a part thereof:

The South 907.50 feet of the West 480 feet of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Twenty (20), Township One Hundred Sixty-three (163) North, Range Thirty-six (36) West.


SECTION 4. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Lake Town Clerk and the Roseau County Auditor.

SECTION 5. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4, and approval of the Ordinance by the Minnesota Municipal Board.
