## ORDINANCE NO. 905.00

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WARROAD TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, the territory abuts upon the corporate limits of the city and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the city; The city council of Warroad ordains:

Section 1. <u>Territory annexed</u>. The corporate limits of the City of Warroad are hereby extended to include the unplatted property described as follows now owned by the city:

That part of Government Lots One (1), Three (3), and Four (4), the Southwest Quarter of the Northeast Quarter (SW\(\frac{1}{4}\) NE\(\frac{1}{4}\)) and the Northeast Quarter of the Northeast Quarter (NE\(\frac{1}{4}\)), Section Thirteen (13); and the Southeast Quarter (SE\(\frac{1}{4}\)) of Section Twelve (12), Township One Hundred Sixty-three (163) North, Range Thirty-seven (37) West; Government Lots Four (4), Nine (9), Eleven (11) and Twelve (12), Section Seven (7), and Government Lots One (1), Two (2) and Six (6), Southeast Quarter of the Northwest Quarter (SE\(\frac{1}{4}\) NW\(\frac{1}{4}\)) and the Southwest Quarter of the Northeast Quarter (SW\(\frac{1}{4}\)) NE\(\frac{1}{4}\)), Section Eighteen (18), Township One Hundred Sixty-three (163) North, Range Thirty-six (36) West of the 5th Principal Meridian, Roseau County, Minnesota, described as follows:

minutes 28 seconds East a distance of 3061.18 feet to the south line of the SW NE NE of said Section 18; thence South 89 degrees 11 minutes 41 seconds West along the south line of the  $SW^{1}_{4}$   $NE^{1}_{4}$  of said Section 18 a distance of 136.50 feet; thence North 42 degrees 02 minutes 02 seconds West a distance of 903.96 feet to the east line of the SE1 NW1 of said Section 18; thence North 41 degrees 01 minutes 47 seconds West a distance of 2562.33 feet to the north line of said Section 18; thence South 88 degrees 53 minutes 47 seconds West along the north line of said Section 18 a distance of 870.00 feet to the point of beginning. Containing 263.92 acres, more or less. Subject to easements, restrictions and reservations or rights whether of record or not.

That part of the Northeast and Northwest Quarters of the Northeast Quarter (NE¼) of Section Nineteen (19) and the Northwest Quarter of the Northwest Quarter (NW¼ NW¼), Section Twenty (20), Township One Hundred Sixtythree (163) North, Range Thirty-six (36) West of the 5th Principal Meridian, Roseau County, Minnesota, described as follows:

Commencing at the northeast corner of said Section 19 being the point of beginning; thence westerly along the north line of said Section 19 having an assumed bearing of South 89 degrees 31 minutes 09 seconds West a distance of 1689.18 feet; thence South 40 degrees 15 minutes 09 seconds East a distance of 1355.07 feet; thence North 48 degrees 36 minutes 32 seconds East a distance of 1591.68 feet to the north line of said thence South 89 degrees 23 minutes 27 Section 20; seconds West along the north line of said Section 20 a 380.59 Excepting distance of feet. therefrom the right-of-ways of Minnesota Trunk Highway Number 313 and the Canadian National Railway. Containing 22.4 acres less. Subject to easements, restrictions, reservations or rights whether of record or not.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County of Roseau, the Lake Township Clerk and the Minnesota Municipal Board.
