ORDINANCE NO. 140

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BAGLEY

WHEREAS, The City of Bagley owns the land described below and

WHEREAS, said tract contains approximately 1.84 acres and abuts the city limits on the North edge of Bagley.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BAGLEY, MINNESOTA, ORDAIN:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of the said territory is now included within the limits of any incorporated city, village, or borough.

SECTION 2: Territory Annexed.

The corporate limits of the city are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the city as effectually as if it had been a part thereof:

All that part of the Northeast Quarter of the Southwest Quarter ((NE¼SW¼) of Section Twenty (20), Township One Hundred Forty-seven (147) North, Range Thirty-seven (37) West of the Fifth P.M., described and bounded as follows: Commencing at the northeast corner of said NE¼SW¼, thence South along the quarterline a distance of 973.6 feet to a point, thence angle South 74°54' West a distance of 465.0 feet to the point of beginning; thence continuing South 74°54' West a distance of 400.0 feet; thence North 15°06' West a distance of 200.0 feet; thence North 74°54' East a distance of 400.0 feet; thence South 15°06' East a distance of 200.0 feet to the point of beginning.

SECTION 3: The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Clerk of Copley Township, the Clearwater County Auditor, the Secretary of State, and the Clearwater County Recorder.

SECTION 4: Effective Date.

This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and upon approval by the Minnesota Municipal Board. Adopted by the Council this 8th day of March, 1994.
