ORDINANCE NO. 171 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LAKE CITY TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA, ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated May 11, 1994 requesting annexation of the territory hereinafter described, was duly presented to the Council on the 13th day of May, 1994; and

WHEREAS, the Petition was signed by two owners, constituting a majority but not all of, a total number of three owners; and

WHEREAS, no objections to the annexation have been received from the Town Board or the Government body of any Municipality whose boundaries abutt upon the boundaries of the land to be annexed; and

WHEREAS, the Town Board of Lake Township, pursuant to a Resolution adopted by the Town Board on June 16, 1994, stated to the Minnesota Municipal Board that it had no objection to the annexation herein described and that it waived the 90 day notice before a City Ordinance could be adopted; and

WHEREAS, a hearing was duly held on August 9, 1994 by the governing body of the City of Lake City, MN, on the proposed annexation after at least 30 days' mailed notice; and

WHEREAS, the land described in the Petition abutts upon the city limits at the Southerly and Westerly boundaries thereof.

NOW, THEREFORE, the Council of the City of Lake City, MN, ordains:

Section 1. The City Council hereby determines (1) that the territory described herein abutts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. The population of the territory is 42.

Section 3. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

The NW-1/4 of the SE-1/4 of Section 9, Township 111 North, Range 12 West (40 acres).

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk and the County Auditor.

Section 5. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the Ordinance by the Minnesota Municipal Board.
