PETITION OF MANTORVILLE TOWNSHIP FOR ANNEXATION
PURSUANT TO MINNESOTA STATUTES 414.033, SUBD. 2 (3)

PETITIONERS STATE: The property owner is required to commence a proceeding under M.S. 414.033, Subd. 2 (3).

It is hereby requested by Mantorville Township, the sole property owner to annex a roadway described herein lying in the Township of Mantorville, Dodge County, Minnesota, described as follows:

The South 50.00 feet of the Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty-eight (28), Township One Hundred Seven North (107N), Range Sixteen West (16W), and
The North 50.00 feet of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twenty-eight (28), Township One Hundred Seven North (107N), Range Sixteen West (16W),
also described as a 100 feet corridor known as Township Road T-41, commencing at the center of Trunk Highway No. 57, running thence easterly 2,640 feet and there terminating

The undersigned is the sole owner of the property proposed for annexation.

The population of the annexation area is zero.

The property is unincorporated and abuts on three sides, to the North, to the West and to the South, on property now included within the City of Kasson.

This property is known as Township Road No. T-41 and also known as 16th Street Northeast, Kasson, Minnesota.

The reason for the requested annexation is: The City would be responsible for repairs, improvements and maintenance of this property,

and is or is about to become urban or suburban in character.

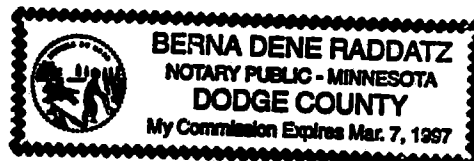
