

Council Member Don Miller introduced the following ordinance and moved for its adoption:

ORDINANCE 19.100

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF VESTA TO INCLUDE CERTAIN LAND OWNED BY JEFF PASKEWITZ ABUTTING THE CITY OF VESTA

WHEREAS, Jeff Paskewitz has filed a petition dated May 30, 1994, requesting that certain land, as legally described below:

All that part of the Southeast Quarter of the Southwest Quarter of Section 16, Township 112 North, Range 38 West in Redwood County, Minnesota, described as follows; Beginning on the north line of the Southeast Quarter of the Southwest Quarter of said Section 16 at a distance of 269.30 feet on a bearing of South 89 degrees 57'05" West from the Northeast Corner of the Southeast Quarter of the Southwest Quarter of said Section 16; thence South 89 degrees 57'05" West along the said north line for 253.09 feet to the southeasterly right-of-way line of Trunk Highway No. 19 as recorded in book 151 of Deeds on Page 767; thence South 37 degrees 44'40" West along the southeasterly line of Trunk Highway No. 19 for 793.65 feet; thence South 52 degrees 15'20" East for 200.00 feet; thence North 37 degrees 44'40" East for 948.75 feet to the point of beginning, containing 4.00 acres, more or less.

WHEREAS, Jeff Paskewitz represent that he is the sole owner of the property, that the property is unincorporated, abuts the limits of the City of Vesta, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, and is approximately four acres in size.

NOW THEREFORE, The City Council of Vesta, Minnesota does hereby ordain:

Section 1. The City council hereby determines and finds that the property abuts the municipality, that the area to be annexed is sixty (60) acres or less, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, that the municipality has received a properly prepared Petition for Annexation from all of the owners of the property, and that the Petition complies with all of the provision of Minnesota Statute 414.033.

Section 2. The property is urban in nature or about to become so.

Section 3. The corporate limits of the City of Vesta are hereby extended to include the Property and the same is hereby annexed to and included within the City of Vesta as if the property had originally been part thereof.

Section 4. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Vesta Township, the Redwood County Auditor, and the Minnesota Secretary of State.

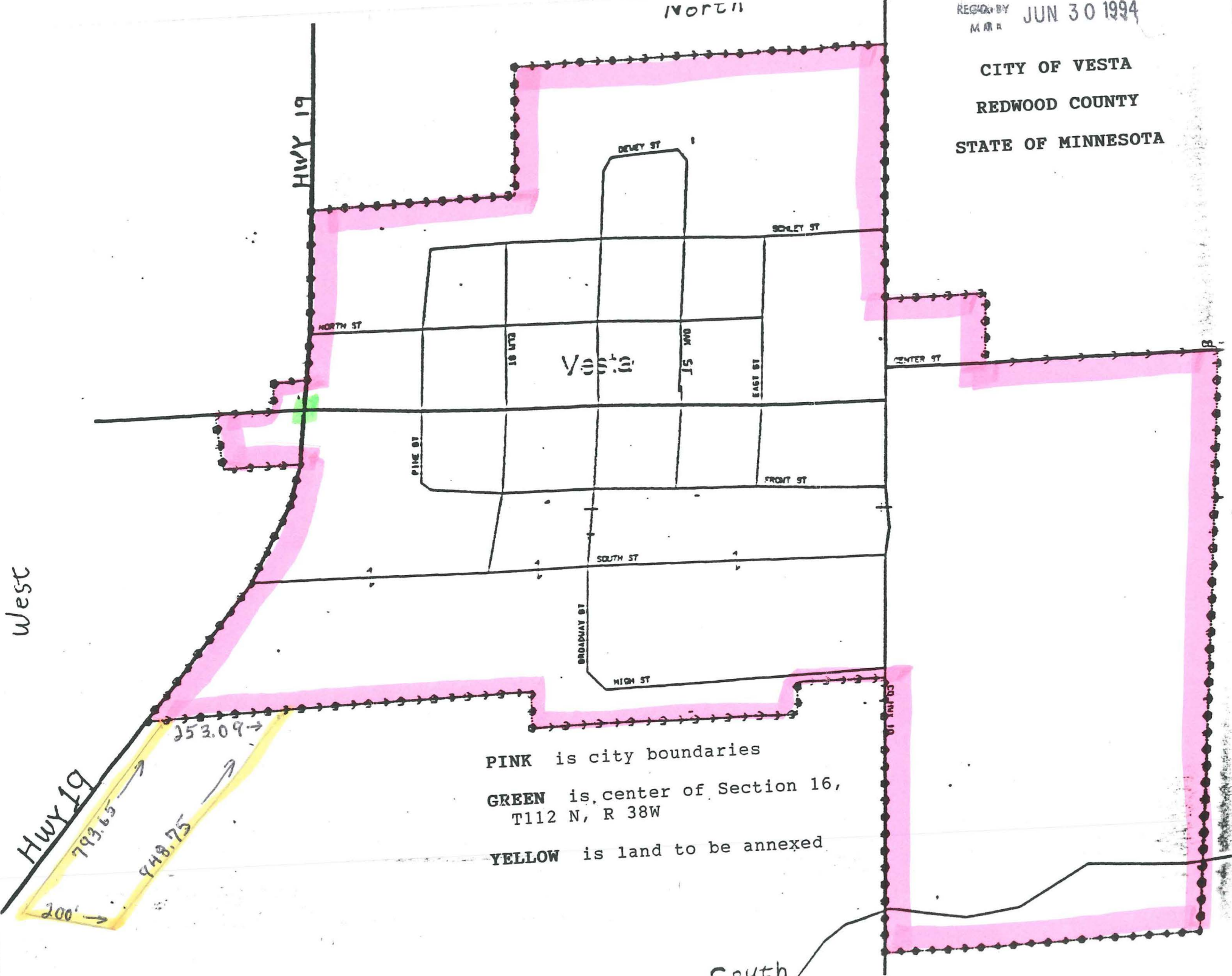
